Devon County Council propose to make this under the Road Traffic Regulation Act 1984 to introduce

BARNSTAPLE: No Waiting At Any Time on specified lengths of Clinton Road, Fortescue Road, Gloster Road, Gorwell Road, Martin Road, North Road, Oakleigh Road, Old Sticklepath Hill, Orchard Terrace & Rumsam Road; **Residents Parking At Any Time Zone B** on a specified length of Oakleigh Road; **Loading Only 8am-6pm** on a specified length of Paiges Lane; **School Entrance Clearway No Stopping At Any Time** on specified lengths of Landkey Road & Old Sticklepath Hill; **Revocation of No Waiting At Any Time** on a specified length of Beech Grove;

BRAUNTON: No Waiting At Any Time on specified lengths of First Field Lane, Fortescue Close, North Street, Second Field Lane; The Moorings & Wrafton Road; **No Waiting 9am-5pm** on a specified length of Beacon Heights;

COMBE MARTIN: No Waiting At Any Time on specified lengths of Buzzacott Lane, Chapel Lane & Highfield Gardens;

CROYDE: No Waiting At Any Time on specified lengths of Cloutmans Lane, Cott Lane, Croyde Road, Hobbs Hill, Home Farm Close, Jones Hill, Lane Head Close, Moor Lane, Orchard Grove, St Marys Road (spur leading to Millers Brook), St Marys Road & Watery Lane;

ILFRACOMBE: No Waiting At Any Time on specified lengths of Belmont Road, Cairn Road, Granville Road, Lane past Hillsborough Cottage, Station Road & Windsor Court; **No Loading At Any Time** on specified lengths of Granville Road;

LYNTON: No Waiting At Any Time on specified lengths of Park Street & the Road from Hollerday Gate to Castle Rock; **No Waiting 10am-6pm Good Friday to 31 October** on a specified length of Longmead; **No Stopping At Any Time** on a specified length of the Road from Hollerday Gate to Castle Rock;

SOUTH MOLTON: No Waiting At Any Time on a specified length of New Road; **No Waiting Mon-Sat 8am-6pm** on a specified length of East Street;

WOOLACOMBE: Limited Waiting 10am-6pm 1 Hour No Return Within 2 Hours on specified lengths of Barton Road & West Road;

Where appropriate there will be the usual exemptions including those in relation to the picking up & setting down of passengers, loading/unloading of goods & disabled persons vehicles.

Statement of Reasons
