

Devon County Council (East Devon HATOC) (Traffic Regulation) Amendment Order

Devon County Council make the following order under sections 1, 2, 4, 32, 35, part IV of schedule 9 of the Road Traffic Regulation Act 1984 & of all other enabling powers

- 1 This order comes into force and may be cited as “Devon County Council (East Devon HATOC) (Traffic Regulation) Amendment Order ”
- 2 The schedules in part 1 are added to Devon County Council (Traffic Regulation & On-Street Parking Places) Consolidation Order 2017 as amended and the lengths of road in part 2 are revoked from the corresponding schedules of the specified orders

AXMINSTER

Schedule 1.001 No Waiting At Any Time

Second Avenue, Axminster

- (i) the north-east side from its junction with Chard Road to its junction with Weycroft Avenue
- (ii) the south-west side from its junction with Chard Road to its junction with Millwey Court

BUDLEIGH SALTERTON

Schedule 1.001 No Waiting At Any Time

Bramble Close, Budleigh Salterton

both sides from its junction with Stoneborough Lane for a distance of 9 metres in a southerly direction

East Budleigh Road, Budleigh Salterton

the east side from a point 24 metres south of its junction with Stoneborough Lane to a point 15 metres north of its junction with Stoneborough Lane

Stoneborough Lane, Budleigh Salterton

the south side from a point 4 metres west of its junction with Bramble Close to a point 3 metres east of its junction with Bramble Close

Church Lane, Clyst St Mary

- (i) the east side from its junction with the A3052 Sidmouth Road for a distance of 114 metres in a southerly direction

- (iii) the west side from its junction with Clyst Valley Road for a distance of 26 metres in a northerly direction

Bath Road, Exmouth

both sides from its junction with Esplanade for a distance of 45 metres in a northerly direction

Fore Street, Exmouth

the north side from a point 142 metres north-west of its junction with Montpellier Road to its junction with Lower Fore Street in a westerly direction

Hillcrest Gardens, Exmouth

- (i) the north-east side from its junction with St Johns Road for a distance of 14 metres in a south-easterly direction
- (ii) the south-west side from its junction with St Johns Road for a distance of 19 metres in a south-easterly direction

Myrtle Row, Exmouth

the south-west side from its junction with Raleigh Road for a distance of 16 metres in a south-easterly direction

St Johns Road, Exmouth

the south-east side from a point 10 metres south-west of its junction with Hillcrest Gardens to a point 10 metres north-east of its junction with Hillcrest Gardens

HONITON

Schedule 1.001 No Waiting At Any Time

Charles Road, Honiton

the inner side kerb line around the play area for its entire length

Courtenay, Honiton

both sides from its junction with Rosemount Lane for a distance of 10 metres in a south-westerly direction

Rosemount Lane, Honiton

the south-west side from a point 14 metres north-west of its junction with Courtenay to a point 17 metres south-east of its junction with Courtenay

OTTERY ST MARY

- (i) the east side from a point 15 metres north of its junction with Butts Road to a point 30 metres south of its junction with Butts Road
- (ii) the west side from a point 3.5 metres north of the extended southern boundary line of No. 1 Butts Road for a distance of 47 metres in a northerly direction

Butts Road, Ottery St Mary

both sides from its junction with Butts Hill for a distance of 10 metres in an easterly direction

SEATON

the west side from a point 103 metres from its junction with Harepath Road for a distance of 11 metres in a southerly direction

the west side from its junction with Brewery Lane for a distance of 7 metres in a southerly direction

Malvern Road, Sidmouth

both sides from its junction with Winslade Road for a distance of 10 metres in a northerly direction

Manstone Avenue, Sidmouth

both sides from its junction with Woolbrook Road for a distance of 63 metres in a north-easterly direction

Pathwhorlands, Sidmouth

- (i) the north side from its junction with Alexandria Road for a distance of 40 metres in a westerly direction
- (ii) the south side from its junction with Alexandria Road for a distance of 30 metres in a westerly direction

Primley Mead, Sidmouth

the west side from a point 4 metres north of the southern extended building line of No. 1 Primley Mead in a northerly direction for the extent of the public highway

Salcombe Road, Sidmouth

the north side from its junction with A375 (Radway) for a distance of 223 metres in an easterly direction

Winslade Road, Sidmouth

the north side from a point 8 metres west of its junction with Malvern Road to a point 8 metres east of its junction with Malvern Road

- (i) the north-east side from its junction with Stowford Rise for a distance of 37 metres in a south-easterly direction
