

Devon County Council (East Devon HATOC) (Traffic Regulation) Amendment Order

Devon County Council propose to make this under the Road Traffic Regulation Act 1984 to introduce

AXMINSTER: No Waiting At Any Time on specified lengths of Second Avenue;

BUDLEIGH SALTERTON: No Waiting At Any Time on specified lengths of Bramble Close, East Budleigh Road and Stoneborough Lane;

CLYST ST MARY: No Waiting At Any Time on specified lengths of Church Lane, Clyst Valley Road and Frog Lane;

EXMOUTH: No Waiting At Any Time on specified lengths of Bath Road, Fore Street, Hillcrest Gardens, Myrtle Row and St Johns Road;

HONITON: No Waiting At Any Time on specified lengths of Charles Road, Courtenay and Rosemount Lane;

OTTERY ST MARY: No Waiting At Any Time on specified lengths of Butts Hill and Butts Road;

SEATON: No Waiting At Any Time on specified lengths of Scalwell Lane and Seaton Down Road; **Revocation of No Waiting At Any Time** on a specified length of Seaton Down Road;

SIDMOUTH: No Waiting At Any Time on specified lengths of Bickwell Valley, Convent Road, Cranford, Malvern Road, Manstone Avenue, Pathwhorlands, Primley Mead, Salcombe Road and Winslade Road; **No Waiting 8am-6pm** on specified lengths of Moor View Close; **No Waiting Mon-Fri 8am-6pm** on specified lengths of Primley Mead; **Buses only 8am-6pm Max Stay 1 Hour No Return Within 1 Hour** on a specified length of The Esplanade;

Where appropriate there will be the usual exemptions including those in relation to the picking up & setting down of passengers, loading/unloading of goods & disabled persons vehicles.

statement of reasons

The restrictions are being proposed to resolve minor local issues that have been reported to the council and considered as part of the East Devon Highways and Traffic Orders Committee annual local waiting restrictions programme. Specific details of what is proposed at each location can be found within the deposit documents.

The restrictions are proposed to avoiding danger to persons or other traffic using the road or for preventing the likelihood of any such danger arising, for facilitating the passage on the road or any other road of any class of traffic (including pedestrians) and to preserve/improving the amenities of the area through which the roads run.
