## Devon County Council (Various Roads, South Zeal) (No Waiting & Parking Restrictions) Amendment Order

Devon County Council propose to make this under the Road Traffic Regulation Act 1984 to introduce the following restrictions in South Zeal in the borough of West Devon

NO WAITING AT ANY TIME on specified lengths of "The Croft", "Road from Shilhayes to Zeal Head Cross", "Road Over Moorlands Bridge" and Tawton Lane

LIMITED WAITING 8AM-6PM 30 MINUTES NO RETURN WITHIN 1 HOUR on a specified length of "Road from Shilhayes to Zeal Head Cross"

SCHOOL ENTRANCE CLEARWAY NO STOPPING AT ANY TIME on a specified length of Tawton Lane

Where appropriate there will be the usual exemptions including those in relation to the picking up & setting down of passengers, loading/unloading of goods & disabled persons vehicles.

## **Statement of Reasons**

The restrictions are being proposed to resolve minor local issues that have been reported to the council and considered as part of the West Devon Highways and Traffic Orders Committee annual local waiting restrictions programme.

Specifically, the proposed restrictions will help in avoiding dangers to persons or other traffic using the road or for preventing the likelihood of any such danger arising, for facilitating the passage on the road or any other road of any class of traffic (including pedestrians) and to preserve/improve the amenities of the area through which the roads run.
