Introduction of **No Waiting At Any Time** in specified sections of; Goblin Lane & Willand Road

Modification of **No Waiting Mon-Sat 8am-6pm** in specified sections of; Willand Road

Removal of **Bus Stop** and marking of **No Waiting At Any Time** in specified sections of; Tiverton Road

TIVERTON

Introduction of **No Waiting At Any Time** in specified sections of; Banksia Close, Blundells Road, Howden Road & Palmerston Park

Removal of **No Waiting At Any Time** in specified sections of; Brewin Road, Church Street & Coles Mead

Introduction of **No Waiting Mon-Fri 10am-4pm** in specified sections of; Tumbling Fields

Where appropriate there will be the usual exemptions including those in relation to the picking up & setting down of passengers, loading/unloading of goods & disabled persons vehicles.

Statement of Reasons

The restrictions are being proposed to resolve minor local issues that have been reported to the council and considered as part of the Mid Devon Highways and Traffic Orders Committee annual local waiting restrictions programme. Specific details of what is proposed at each location can be found within the deposit documents.

The restrictions are proposed to avoiding danger to persons or other traffic using the road or for preventing the likelihood of any such danger arising or for preventing damage to the road or to any building on or near the road, for facilitating the passage on the road or any other road of any class of traffic (including pedestrians) and to preserve/ improve the amenities of the area through which the roads run.
