

**Devon County Council (Various Roads, Bere Alston, Hatherleigh, North Tawton, Okehampton & Tavistock)
(Waiting Restrictions) Amendment Order**

Devon County Council propose to make this under the Road Traffic Regulation Act 1984 to introduce:

BERE ALSTON

No Waiting At Any Time on specified lengths of Chapel Street & Pilgrim Drive;

HATHERLEIGH

No Waiting At Any Time on a specified length of South Street;

NORTH TAWTON

No Waiting At Any Time on a specified length of Exeter Street;

OKEHAMPTON

No Waiting At Any Time on a specified length of Simmons Way;

TAVISTOCK

No Waiting At Any Time on specified lengths of Glanville Road, Old Exeter Road & Parkwood Road.

Where appropriate there will be the usual exemptions including those in relation to the picking up & setting down of passengers, loading/unloading of goods & disabled persons vehicles.

statement of reasons

The restrictions are being proposed to resolve minor local issues that have been reported to the council and considered as part of the West Devon Highways and Traffic Orders Committee annual local waiting restrictions programme. In addition, it is proposed to make adjustments to update descriptions to ensure measurements in the traffic order correspond with existing on street markings. Specific details of what is proposed at each location can be found within the deposit documents.

The restrictions are proposed to avoiding danger to persons or other traffic using the road or for preventing the likelihood of any such danger arising, for facilitating the passage on the road or any other road of any class of traffic (including pedestrians) and to preserve/improving the amenities of the area through which the roads run.

5717-008	Debo Sellis	Tavistock	Old Exeter Road	Introduce No Waiting At Any Time outside number 69	The current limited waiting bay extends across dropped kerb. Double yellow lines across the dropped kerb will prevent obstruction of access to off road parking place.
5717-009	Debo Sellis	Tavistock	Parkwood Road	Introduce No Waiting At Any Time	At the entrance to Vigo Mews, double yellow lines to prevent obstructive parking around the junction to this private cul-de-sac.
