

**Devon County Council (Rosebarn Lane Area, Exeter)
(No Waiting At Any Time) Amendment Order 2019**

Devon County Council make the following order under sections 1, 2, 4 & part IV of schedule 9 of the Road Traffic Regulation Act 1984 & of all other enabling powers

- 1 This order comes into force 26th September 2019 and may be cited as “Devon County Council (Rosebarn Lane Area, Exeter) (No Waiting At Any Time) Amendment Order 2019”
- 2 The schedules in part 1 are added to Devon County Council (Traffic Regulation & On-Street Parking Places) Consolidation Order 2017 as amended and the lengths of road in part 2 are revoked from the corresponding schedules of that order

PART 1 RESTRICTIONS

Schedule 1.001 No Waiting At Any Time

Aldrin Road, Exeter

- (i) both sides from its junction with Collins Road for a distance of 11 metres in a southerly direction
- (ii) the south-east side from its junction with Rosebarn Lane in a north-easterly direction for a distance of 40 metres

Armstrong Avenue, Exeter

both sides from its junction with Collins Road for a distance of 11 metres in a southerly direction

Collins Road, Exeter

- (i) the north side from a point 13 metres south-west of its junction with Mayflower Avenue to a point 13 metres east of that junction
- (ii) the north-west side from a point 23 metres south-west of its junction with Mayflower Avenue for a distance of 6 metres in a south-westerly direction
- (iii) the north-west side from a point 34 metres south-west of its junction with Mayflower Avenue for a distance of 7 metres in a south-westerly direction
- (iv) the north-west side from a point 46 metres south-west of its junction with Mayflower Avenue for a distance of 6 metres in a south-westerly direction
- (v) the north-west side from a point 57 metres south-west of its junction with Mayflower Avenue for a distance of 8 metres in a south-westerly direction
- (vi) the south side from a point 10 metres west of its junction with Aldrin Road to a point 10 metres east of that junction
- (vii) the south-east side from its junction with Rosebarn Lane to a point 13 metres east of its junction with Armstrong Avenue

Doriam Close, Exeter

- (i) the north-west side from its junction with Pennsylvania Road to its intersection with the extended north-eastern kerbline of Patricia Close
- (ii) the south-east side from its junction with Patricia Close to a point 65 metres south-west of its junction with Pennsylvania Road
- (iii) the south-east side from its junction with Pennsylvania Road for a distance of 31 metres in a south-westerly direction
- (iv) the south-east side from a point 36 metres south-west of its junction with Pennsylvania Road for a distance of 9 metres in a south-westerly direction

Florida Drive, Exeter

- (i) the east side from its junction with Stoke Valley Road for a distance of 13 metres in a southerly direction
- (ii) the west side from its junction with Stoke Valley Road for a distance of 16 metres in a southerly direction

Mayflower Avenue, Exeter

both sides from its junction with Collins Road for a distance of 11 metres in a northerly direction

Patricia Close, Exeter

the north-east side from its junction with Doriam Close for a distance of 8 metres in a south-easterly direction

Pennsylvania Road, Exeter

- (i) the east side from its intersection with the extended south-eastern building line of number 202 Pennsylvania Road to the boundary of Nos. 198/200 Pennsylvania Road
- (ii) the east side from its junction with Stoke Valley Road to a point 148 metres north-west of its intersection with the extended south-eastern building line of number 202 Pennsylvania Road
- (iii) the north-east side from a point 20 metres north-west of its intersection with the extended south-eastern building line of number 202 Pennsylvania Road for a distance of 45 metres in a north-westerly direction
- (iv) the north-east side from a point 80 metres north-west of its intersection with the extended south-eastern building line of number 202 Pennsylvania Road for a distance of 12 metres in a north-westerly direction
- (v) the north-east side from a point 103 metres north-west of its intersection with the extended south-eastern building line of number 202 Pennsylvania Road for a distance of 40 metres in a north-westerly direction
- (vi) the west and south side from its junction with Prince of Wales Road to a point 11 metres north of the centre line of Stoke Valley Road

Rosebarn Lane, Exeter

- (i) the east side from a point 44 metres north of its junction with Road from Rosebarn Lane to Stoke Hill to a point 14 metres north of its junction with the access road to the garages adjacent to No. 8
- (ii) the east side from a point 205 metres south-east of its junction with Collins Road to a point 50 metres north of its junction with access to garages
- (iii) the north-east side from a point 74 metres south-east of its junction with Pennsylvania Road to a point 76 metres south-east of its junction with Collins Road
- (iv) the north-east side from a point 109 metres south-east of its junction with Collins Road for a distance of 60 metres in a south-easterly direction
- (v) the north-east side from a point 41 metres south-east of its junction with Pennsylvania Road for a distance of 7 metres in a south-easterly direction
- (vi) the north-east side from a point 57.5 metres south-east of its junction with Pennsylvania Road for a distance of 6.5 metres in a south-easterly direction
- (vii) the north-east side from a point 81 metres south-east of its junction with Collins Road for a distance of 10 metres in a south-easterly direction
- (viii) the north-east side from a point 96 metres south-east of its junction with Collins Road for a distance of 8 metres in a south-easterly direction
- (ix) the north-east side from a point 184 metres south-east of its junction with Collins Road for a distance of 11 metres in a south-easterly direction
- (x) the south-west side from a point 96 metres north-west of its junction with Rosebarn Avenue for a distance of 62 metres in a north-westerly direction

- (xi) the south-west side from a point 168 metres north-west of its junction with Rosebarn Avenue for a distance of 6 metres in a north-westerly direction
- (xii) the south-west side from a point 184 metres north-west of its junction with Rosebarn Avenue for a distance of 62 metres in a north-westerly direction
- (xiii) the south-west side from its junction with Pennsylvania Road in a south-easterly direction to a point 276 metres north-west of its junction with Rosebarn Avenue

Stoke Valley Road, Exeter

- (i) the north side from a point 60 metres east of its junction with Road from Stoke Valley Road to Rollestone Barton to a point 8 metres east of its junction with California Close
- (ii) the south side from a point 35 metres north-east of its junction with Pennsylvania Road to a point 33 metres east of its junction with Florida Drive
- (iii) the south-east side from its junction with Pennsylvania Road for a distance of 20 metres in a north-easterly direction

PART 2 REVOKED RESTRICTIONS

Schedule 1.001 No Waiting At Any Time

Aldrin Road, Exeter

the south-east side from its junction with Rosebarn Lane in a north-easterly direction for a distance of 20 metres

Collins Road, Exeter

the south-east side from its junction with Rosebarn Lane in a north-easterly direction for a distance of 10 metres

Doriam Close, Exeter

- (i) the north side from its junction with Pennsylvania Road to its junction with Argyll Road
- (ii) the south-east side from its junction with Pennsylvania Road for a distance of 7 metres in a south-westerly direction

Pennsylvania Road, Exeter

- (i) the east side from a point 4 metres south-east of its intersection with the extended south-eastern building line of number 202 Pennsylvania Road to the boundary of Nos. 198/200 Pennsylvania Road
- (ii) the north-east side from a point 16 metres north-west of the boundary of Nos. 222/224 Pennsylvania Road for a distance of 58 metres in a north-westerly direction
- (iii) the south-west side from a point 11 metres north-west of its junction with Doriam Close to a point 11 metres south-east of that junction
- (iv) the west side from its junction with Prince of Wales Road to a point 3 metres south-east of its intersection with the extended south-eastern building line of number 202 Pennsylvania Road

Rosebarn Lane, Exeter

- (i) the east side from a point 44 metres north of its junction with the Rosebarn Lane and Stoke Hill link road to a point 19 metres north of its junction with the access road to the garages
- (ii) the east side from a point 37 metres north-west of its junction with Armstrong Avenue in a south-easterly direction to its junction with the access road to 24 to 32 Rosebarn Lane
- (iii) the north-east side from a point 15 metres north-west of its junction with Collins Road in a south-easterly direction to a point 25 metres south-east of that junction
- (iv) the south side from its junction with Pennsylvania Road in a south-easterly direction to the boundary of Nos. 73/75 Rosebarn Lane
- (v) the south-west side from a point 5 metres north-west of the boundary of Nos. 59/61 Rosebarn Lane in a south-easterly direction for a distance of 25 metres

Stoke Valley Road, Exeter

the south-east side from its junction with Pennsylvania Road for a distance of 10 metres in a north-easterly direction
