

Devon County Council (Exeter City Centre) (Waiting Restrictions) (Part 5) Amendment Order

Devon County Council make the following order under sections 1, 2, 4, 32, 35, part IV of schedule 9 of the Road Traffic Regulation Act 1984 & of all other enabling powers

- 1 This order comes into force " and may be cited as " Amendment Order "
- 2 The schedules in part 1 are added to Devon County Council (Traffic Regulation & On-Street Parking Places) Consolidation Order 2020 as amended and the lengths of road in part 2 are revoked from the corresponding schedules of that order

PART 1 RESTRICTIONS

Schedule 1.001 No Waiting At Any Time

Bampfylde Street, Exeter

- (i) the north-west side from a point 8 metres north-east of its north-eastern junction with Stover Court in a south-westerly direction to a point 32.5 metres south-west of its northern junction with Bude Street
- (ii) the north-west side from a point 23 metres north-east of its north-eastern junction with Stover Court in a north-easterly direction to its junction with Summerland Street

Belgrave Road, Exeter

the south-east side from its junction with Cheeke Street in a north-easterly direction for a distance of 10 metres

Cheeke Street, Exeter

both sides from its junction with Paris Street Roundabout to its junction with Sidwell Street

Paris Street, Exeter

- (i) the north side from its junction with Sidwell Street in an easterly direction to a point 105 metres east of its junction with Bampfylde Street
- (ii) the north side from a point 135 metres east of its junction with Bampfylde Street in an easterly direction to its junction with Paris Street Roundabout

Schedule 8.001 Loading Only At Any Time

Belgrave Road, Exeter

the south-east side from a point 10 metres north-east of its junction with Cheeke Street in a north-easterly direction for a distance of 12 metre

Schedule 8.060 Goods Vehicles Loading Only At Any Time

Paris Street, Exeter

the north side from a point 105 metres east of its junction with Bampfylde Street in an easterly direction for a distance of 30 metres

Schedule 11.030 Local Buses Only At Any Time

Bampfylde Street, Exeter

the north-west side from a point 8 metres north-east of its north-eastern junction with Stover Court in a north-easterly direction for a distance of 15 metres

PART 2 REVOKED RESTRICTIONS

Schedule 1.001 No Waiting At Any Time

Bampfylde Street, Exeter

the north-west side from its junction with Summerland Street in a south-westerly direction to a point 32.5 metres south west of its northern junction with Bude Street

Belgrave Road, Exeter

the south-east side from its junction with Cheeke Street for a distance of 5 metres in a north-easterly direction

Cheeke Street, Exeter

both sides from its junction with Paris Street Roundabout to its junction with Sidwell Street

Paris Street, Exeter

- (i) the north side from its junction with Bampfylde Street to its junction with Paris Street Roundabout
- (ii) the north-east side from its junction with Sidwell Street to its junction with Bampfylde Street

Schedule 8.001 Loading Only At Any Time

Belgrave Road, Exeter

the south-east side from a point 5 metres north-east of its junction with Cheeke Street for a distance of 18 metres in a north-easterly direction
