No Waiting At Any Time on a specified length of Polsloe Road;

Pay & Display (Tariff Exeter M) Mon-Fri excl Bank Hols 10am-4pm Max Stay 2 Hours (Exemption for Residents Zone C & S2 Permit Holders) (£1.30 for 2 hours and free on Sat/Sun and Banks Hols.) on a specified length of Gladstone Road

Revocation of No Waiting At Any Time on a specified length of South Avenue;

Revocation of Pay & Display (Tariff Exeter M) Mon-Fri excl Bank Hols 10am-4pm Max Stay 2 Hours (Exemption for Residents Zone C Permit Holders) on a specified length of Gladstone Road;

Revocation of Pay & Display (Tariff Exeter M) Mon-Fri excl Bank Hols 10am-4pm Max Stay 2 Hours (Exemption for Residents Zone S2 Permit Holders on a specified length of Polsloe Road.

Under the Road Traffic Regulation Act 1984 Devon County Council is proposing to install new **Parallel Crossing** in Exeter on Polsloe Road, centred approximately 16 metres south of the junction with Gladstone Road.

Statement of Reasons

Devon County Council are progressing plans for improvements to pedestrian and cyclist infrastructure in this area. Footways and cycleways provide important links for residents to access place of work, schools, shops and wider community facilities like sports centres and hospitals. The proposed crossing and cycle facility on Polsloe Road and Gladstone Road are on the new E3 strategic cycle route which runs from the Redhayes Bridge, west through Whipton, Heavitree and towards the City Centre and forms part of Exeter's overall strategic cycle network. Polsloe Road is a busy road with two-way peak hour flows of up to 700 vehicles an hour and is unattractive to less confident cyclists so the proposal to provide a new parallel crossing and cycle facilities along Polsloe Road, from Regents Park to Gladstone Road, would provide a safe and attractive facility for all users and deliver an extension of the E3 route into Newtown and towards the city centre, providing Heavitree hospital, supermarket and riverside.

The new crossing and cycle facility will require the removal of the parking on Polsloe Road (between Regents Park and South Avenue). To mitigate this loss, changes are proposed to allow an additional space in South Avenue and to allow S2 permit holders to park within the pay & display in Gladstone.

Specifically the orders will avoid danger to persons or other traffic using the road or any other road or for preventing the likelihood of any such danger arising and to preserve or improve the amenities of the area through which the road runs.
