Introduce **Disabled Badge Holders Only At Any Time** on a specified length of The Strand;

EXETER

Introduce **Disabled Badge Holders Only At Any Time** on specified lengths of Cowick Road; Elton Road; Monks Road and Tuckfield Close;

Revoke **Disabled Badge Holders Only At Any Time** on specified lengths of Draycott Close; Hamilton Avenue; Toronto Road and Walnut Road;

EXMOUTH

Introduce **Disabled Badge Holders Only At Any Time** on specified lengths of Fore Street; Moorfield Close and Mountain Close;

ILFRACOMBE

Introduce **Disabled Badge Holders Only At Any Time** on specified lengths of Station Road; Revoke **Disabled Badge Holders Only At Any Time** on a specified length of Station Road;

NORTH TAWTON

Revoke **Disabled Badge Holders Only At Any Time** on a specified length of Exeter Street;

SIDMOUTH

Introduce **Disabled Badge Holders Only At Any Time** on specified lengths of Lawn Vista;

Statement of Reasons

The purpose of the proposed Traffic Regulation Order is to implement regulatory disabled bays that have been requested throughout the County; to remove regulatory disabled bays no longer required and to adjust certain measurements in the Order so they correspond with existing on street road markings.

Specifically, the Order if made will preserve or improve the amenities of the area through which the road runs.
