

**Devon County Council (Various Roads, Exmouth) (Control of Waiting & Pay and Display)
Amendment Order**

Devon County Council makes the following order under 1, 2, 4, 32, 35, 45, 46, 49, 53, part IV of schedule 9 of the Road Traffic Regulation Act 1984 & of all other enabling powers

- 1 This order comes into force _____ and may be cited as “Devon County Council (Various Roads, Exmouth) (Control of Waiting & Pay and Display) Amendment Order _____”
- 2 The schedules in part 1 are added to Devon County Council (Traffic Regulation & On Street Parking Places) Consolidation Order 2020 as amended and the lengths of road in part 2 are revoked from the corresponding schedules of that order

PART 1 RESTRICTIONS

Schedule 1.01 No Waiting At Any Time

Alexandra Terrace, Exmouth

- (i) the north-west side from its junction with Esplanade to a point 9 metres north-east of its junction with Morton Road
- (ii) the south-east side from its junction with Esplanade to its junction with Beacon Hill in a north-easterly direction

Alston Terrace, Exmouth

- (i) the north-east side from its junction with Morton Crescent Mews for a distance of 12 metres in a north-westerly direction

Esplanade, Exmouth

- (i) the north side from its junction with St Andrews Road in a south-easterly direction to a point 83 metres north-west of its junction with Carlton Hill
- (ii) the south side from a point 244 metres west of its junction with Bath Road for a distance of 7 metres in a north-westerly direction
- (iii) the south side from a point 463 metres west of its junction with Bath Road to its junction with Mamhead View in a north-westerly direction
- (iv) the south-west side from a point 69 metres north-west of the extended boundary between Bath House & Channel View buildings for a distance of 29 metres in a north-westerly direction
- (v) the south-west side from a point 148 metres north-west of the extended boundary between Bath House and Channel View Buildings for a distance of 86 metres in a north-westerly direction

Mamhead View, Exmouth

- (i) the north side from its junction with Victoria Road to its junction with St Andrews Road in a south-easterly direction
- (ii) the south side from its junction with Esplanade to a point opposite its junction with Victoria Road in a north-westerly direction

Morton Crescent Mews, Exmouth

- (i) the north side from its junction with Morton Road to its junction with Alston Terrace in a westerly then south-westerly direction
- (ii) the south side from its junction with Morton Road to its junction with Road from Esplanade to Alston Terrace in a westerly then south-westerly direction

Road from Esplanade to Alston Terrace, Exmouth

- (i) the north-west side from its junction with Esplanade to its junction with Alston Terrace in a north-easterly direction
- (ii) the south-east side from its junction with Esplanade to its junction with Morton Crescent Mews in a north-easterly direction

Schedule 5.179 Pay & Display (Tariff Exmouth A) 9am-6pm Max Stay 3 Hours**Esplanade, Exmouth**

- (i) the south side from a point 202 metres west of its junction with Bath Road for a distance of 42 metres in a north-westerly direction
- (ii) the south side from a point 251 metres west of its junction with Bath Road for a distance of 96 metres in a north-westerly direction
- (iii) the south-west side from a point 98 metres north-west of the extended boundary between Bath House & Channel View buildings for a distance of 50 metres in a north-westerly direction
- (iv) the south-west side from a point 18.6 metres north-west of the extended boundary between Bath House & Channel View buildings for a distance of 50.4 metres in a north-westerly direction

- (i) the north-west side from its junction with Morton Road for a distance of 9 metres in a north-easterly direction
- (ii) the south-east side from its junction with Esplanade to its junction with Beacon Hill

Alston Terrace, Exmouth

the north-east side from its junction with Morton Crescent Rear Service Road for a distance of 12 metres in a north-westerly direction

Esplanade, Exmouth

- (i) the north side from a point 343 metres west of its junction with Carlton Hill to its junction with Victoria Road
- (ii) the south side from its junction with Alexandra Terrace for a distance of 78 metres in an easterly direction

Mamhead View, Exmouth

the south side from its junction with Victoria Road for a distance of 210 metres in an easterly direction

Morton Crescent (rear Service Road), Exmouth

- (i) the north side from its junction with Morton Road to its junction with Alston Terrace
- (ii) the north-west side from its junction with Gertrude Terrace for a distance of 11 metres in a north-easterly direction
- (iii) the north-west side from a point 28 metres north-east of its junction with Gertrude Terrace for a distance of 23 metres in a north-easterly direction
- (iv) the south side from its junction with Morton Road to its junction with Esplanade

Schedule 5.179 Pay & Display (Tariff Exmouth A) 9am-6pm Max Stay 3 Hours

Esplanade, Exmouth

- (i) the south side from a point 250 metres north-west of Beach Gardens south eastern boundary line for a distance of 83 metres in a north-westerly direction
- (ii) the south side from a point 202 metres west of its junction with Bath Road for a distance of 145 metres in a westerly direction
- (iii) the south-west side from a point 96.6metres north-west of the boundary line of The Pavilion for a distance of 16.4 metres in a north-westerly direction
