

**Esplanade & Road from Esplanade to Alston Terrace, Exmouth
Proposed Control of Waiting, Pay and Display Amendments & One Way**

Devon County Council propose to make these under the Road Traffic Regulation Act 1984 for Exmouth:

Devon County Council (Various Roads, Exmouth) (Control of Waiting & Pay and Display) Amendment Order 5854 to introduce

NO WAITING AT ANY TIME on specified lengths of **Esplanade** and **Road from Esplanade to Alston Terrace**;

PAY & DISPLAY (TARIFF EXMOUTH A inc Bank Hols exc Christmas Day: 1 Apr-30 Sep 1 hour £1.30, 2 hours £2.50, 3 hours £3.70; 1 Oct-31 Mar 1 hour 90p, 2 hours £2.20, 3 hours £3.40) 9AM-6PM MAX STAY 3 HOURS on a specified length of **Esplanade**

There will be the usual exemptions including those in relation to the picking up & setting down of passengers, loading/unloading of goods & disabled persons vehicles.

Devon County Council (Road from Esplanade to Alston Terrace, Exmouth) (One Way) Order 5853 to introduce

ONE WAY on the **Road from Esplanade to Alston Terrace**, from its junction with Esplanade to its junction with Alston Terrace and Morton Crescent Mews, in a north-easterly direction only

Statement of Reasons

As part of the Exmouth Tidal Defence Scheme, it is proposed to amend the waiting restrictions on the Esplanade and Road from Esplanade to Alston Terrace to accommodate the new road humps/raised tables for the new sliding flood prevention gates. It is also proposed as part of the scheme to introduce a one way on the Road from Esplanade to Alston Terrace. In addition, it is also proposed to update descriptions and road names (in accordance with the National Street Gazetteer) in the current traffic order to reflect what is currently marked on street in vicinity of the proposals.

Specifically, the orders will preserve or improve the amenities of the area through which the road runs.
