

Devon County Council (South Hams HATOC) (Traffic Regulation) Amendment Order

Devon County Council make the following order under sections 1, 2, 4, 32, 35, part IV of schedule 9 of the Road Traffic Regulation Act 1984 & of all other enabling powers

- 1** This order comes into force and may be cited as “Devon County Council (South Hams HATOC) (Traffic Regulation) Amendment Order ”
- 2** The schedules in part 1 are added to Devon County Council (Traffic Regulation & On-Street Parking Places) Consolidation Order 2020 as amended and the lengths of road in part 2 are revoked from the corresponding schedules of that order

PART 1 RESTRICTIONS

IVYBRIDGE

Schedule 1.001 No Waiting At Any Time

Woolcombe Lane, Ivybridge

the south side from a point 19 metres east of its junction with Okehampton Way for a distance of 37 metres in an easterly direction

KINGSWEAR

Schedule 4.102 Limited Waiting 8.30am-5.30pm 20 Minutes No Return Within 2 Hours

Fore Street, Kingswear

the north-west side from a point 27 metres south-west of its junction with Church Hill in a south-westerly direction for a distance of 13 metres

PLYMPTON

Schedule 1.001 No Waiting At Any Time

Western Wood Way, Langage Business Park, Plympton

- (i) the west and north side from a point 115 metres north of its junction with Holland Road for a distance of 281 metres in a northerly then westerly direction
- (ii) the west side from its junction with Holland Road for a distance of 91.5 metres in a northerly direction

ROBOROUGH

Parkwood Close, Roborough

both sides from a point 185 metres north-west of its junction with Broadley Park Road to its northern extent including its western spur

the south-east side from a point 7 metres north-east of its junction with Hillbrook Road to a point 3 metres south-west of its junction with Hillbrook Road

WEMBURY

Schedule 1.001 No Waiting At Any Time

Church Road, Wembury

- (i) the north-west side from its junction with Southland Park Road to a point 35 metres south-west of the property boundary of 146 Church Road and the electric substation in a south-westerly direction
- (ii) the north-west side from its junction with Road from Langdon Barton Farm to Church Road to a point 4 metres south-west of the north-eastern building line of 150 Church Road

- (iii) the south-east side from its junction with Cliff Road to its junction with Road to Wembury Beach

Road from Langdon Barton Farm to Church Road, Wembury

both sides from its junction Church Road for a distance of 52 metres in a north-westerly direction

Road to Wembury Beach, Wembury

- (i) the east side from its junction with Church Road for a distance of 18 metres in a southerly direction
- (ii) the west side from its junction with Road from Langdon Barton Farm to Church Road for a distance of 13 metres in a southerly direction

both sides from a point 10 metres west of its junction with Hern Lane to a point 10 metres east of that junction

- (ii) the west side from a point 123 metres north of its junction with Holland Road for a distance of 113 metres in a northerly direction
- (iii) the west side from a point 239 metres north of its junction with Holland Road for a distance of 38 metres in a northerly direction
- (iv) the west side from a point 57 metres north of its junction with Holland Road for a distance of 32 metres in a northerly direction
- (v) the west side from its junction with Holland Road for a distance of 19 metres in a northerly direction

Church Road, Wembury

- (i) the north-west side from a point 4 metres south-west of its junction with Southland Park Road for a distance of 149 metres in a south-westerly direction
- (ii) the north-west side from a point 194 metres south-west of its junction with Southland Park Road for a distance of 104 metres in a south-westerly then north-westerly direction
- (iii) the south-east side from a point 4 metres south-west of its junction with Hawthorn Park Road for a distance of 223 metres in a south-westerly direction

Road to Wembury Beach, Wembury

- (i) both sides from its junction with Church Road for a distance of 15 metres in a south-westerly direction
- (ii) both sides from its junction with Church Road for a distance of 15 metres in a south-westerly direction

Henacre Road, Kingsbridge

the north-west side from a point 5 metres west of the property boundary of 32A Henacre Close to its junction with Coronation Road

the north-west side from a point 27 metres south-east of its junction with Church Hill in a south-westerly direction for a distance of 13 metres
