

Devon County Council (Exeter HATOC) (Traffic Regulation) Amendment Order

Devon County Council propose to make this under the Road Traffic Regulation Act 1984 to introduce

EXETER: No Waiting At Any Time on specified lengths of Barley Mount, Beacon Avenue, Cambridge Street, Causey Lane, Chieftain Way, Coates Road, Commins Road, Dawlish Road, Dunsford Road, Farm Hill, Gladstone Road, Gloucester Road, Higher Kings Avenue, Kingfisher Way, Kinnerton Way, Ladysmith Road, Lords Way, Nadder Park Road, Old Tiverton Road, Pamela Road, Prince Of Wales Road, Rosebarn Lane, Russell Way, Southbrook Road, Southernhay East, Summer Close, Tollards Road, Well Street, Wheatley Close, Wilford Road and Willsdown Road; **Revoke No Waiting At Any Time** on a specified length of Wykes Road; **No Waiting 8am-6pm** on a specified length of Hele Road; **No Waiting Mon-Fri 8am-6pm** on a specified length of Rosebarn Lane; **No Waiting Mon-Sat 8am-6pm** on specified lengths of Horseguards; **No Waiting Mon-Fri 7am-9:30am and 3pm-5pm** on a specified length of Quarry Lane; **Limited Waiting Mon-Sat 9am-6pm 2 Hours No Return Within 4 Hours** on specified lengths of Franklin Street, Monks Road, Roberts Road and Temple Road; **Limited Waiting Mon-Fri 10am-5pm 2 Hours No Return Within 4 Hours (Exemption for Residents Zone N Permit Holders)** on a specified length of Kipling Drive; **Pay & Display (Tariff Exeter B: Mon-Sat 8am-6pm 30 mins 80p, 1 hour £1.90, 2 hours £3.30, Sun & Bank Hols 11am-5pm, 1 hour £1.30, 2 hours £2.80) Max Stay 2 Hours** on a specified length of Red Lion Lane; **Pay & Display (Tariff Exeter E Mon-Sat 9am-6pm 2 hours £2.20, 4 hours £4.20, over 4 hours £6, Sun & Bank Hols 11am-5pm 4 hours £1.30, over 4 hours £2.50)** on specified lengths of Prince of Wales Road; **Residents Parking At Any Time Zone C** on a specified length of Codrington Street; **Residents Parking At Any Time Zone D** on a specified length of Temple Road; **Residents Parking At Any Time Zone T3** on specified lengths of Monks Road; **Disabled Badge Holders Only At Any Time** on a specified length of Ladysmith Road; **Loading Only At Any Time** on specified lengths of North Street; **School Entrance Clearway – No Stopping At Any Time** on specified lengths of Ladysmith Road and Pretoria Road; **Pay by Phone (Tariff Exeter K1: Mon-Fri excl Bank Hols 10am-4pm 30 mins 50p, 1 hour £1.30, 2 hours £3.30, 4 hours £5.50) Max Stay 4 Hours (Exemption for Residents Zone R Permit Holders)** on a specified length of Salmonpool Lane;

TOPSHAM: No Waiting At Any Time on specified lengths of Elm Grove Road, Higher Shapter Close and The Strand;

Residents, charity business occupier permits £30 annually, visitor permits £30 per batch of 30, business permits annual cost: 1st permit £30, 2nd permit £75, 3rd permit £150; guest house/hotel visitors permit £30 per batch of 20 permits. Essential visitor permits are free.

Where appropriate there will be the usual exemptions including those in relation to picking up/setting down passengers, loading/unloading goods & disabled persons vehicles.
