# Devon County Council (WEST DEVON HATOC) (Traffic Regulation) Amendment Order

Devon County Council make the following order under sections 1, 2, 4, 32, 35 and part IV of schedule 9 of the Road Traffic Regulation Act 1984 & of all other enabling powers

- 1. This order comes into force and may be cited as "Devon County Council (WEST DEVON HATOC) (Traffic Regulation) Amendment Order "

#### Station Road, Mary Tavy

the north-west side from its junction with Road From Walford House To Mary Tavy Inn (A386) for a distance of 13 metres in a south-westerly direction

## NORTH TAWTON

Barton Street, North Tawton

the south-east side from its junction with High Street for a distance of 71 metres in a southwesterly direction
