

**Devon County Council (Various Streets, Devon) (Disabled Parking & Control of Waiting) (No.24)
Amendment Order**

Devon County Council make the following order under sections 1, 2, 4, 32, 35, 45, 46, 49, 53, part IV of schedule 9 of the Road Traffic Regulation Act 1984 and of all other enabling powers

- 1 This order comes into force and may be cited as “Devon County Council (Various Streets, Devon) (Disabled Parking & Control of Waiting) (No.24) Amendment Order ”
- 2 The schedules in part 1 are added to Devon County Council (Traffic Regulation & On-Street Parking Places) Consolidation Order 2020 as amended and the lengths of road in part 2 are revoked from the corresponding schedules of the specified orders

BIDEFORD

Meddon Street, Bideford

the south side from a point 77 metres west of its junction with Torridge Hill for a distance of 7 metres in a westerly direction

EXETER

Schedule 1.001 No Waiting At Any Time

Union Road, Exeter

the north side from a point 136 metres east of its junction with Maryfield Avenue for a distance of 25 metres in an easterly direction

Baker Street, Exeter

(the east side from a point 31.6 metres south of its junction with Magdalen Road for a distance of 133 metres in a southerly direction

- (ii) the south side from a point in line with the boundary of Nos 15 & 17 Union Road to a point 6.6 metres west of that boundary

the north-west side from the boundary of Nos. 45/47 for a distance of 7 metres in a south-westerly direction

Wykes Road, Exeter

the south side from the boundary of Nos. 20/22 for a distance of 6.6 metres in an easterly direction
