

Centenary Way and Bradley Road, Bovey Tracey
Proposed Introduction of 30mph Speed Limit and Prohibition of All Vehicles Amendments Order

Devon County Council under the Road Traffic Regulation Act 1984 propose:

Devon County Council (Centenary Way, Bovey Tracey) Amendment Order 5538 To EXTEND the 30mph speed limit by virtue of street lighting (RESTRICTED ROAD) on the **B3344** from a point 59 metres south-east of its junction with Le Morlay-Littry Way, to a point 124 metres south-east of its south-eastern junction with Centenary Way. To introduce a **30mph speed limit** on the **B3344** from a point 124 metres east of its south-eastern junction with Centenary Way, to a point 185 metres south-east of that junction and on **Bradley Road** (Spur opposite Centenary Way) for its entire length.

Devon County Council (Bradley Road, Bovey Tracey) (Prohibition of All Vehicles) Amendment Order 5851 to introduce in Bovey Tracey Prohibition of All Vehicles on specified lengths of **Bradley Road** to create a spur opposite the south-eastern junction of Centenary Way

Statement of Reason:

Following the recent construction of the new housing development to the north of the B3344 at Bradley Bends, a section of the B3344 has been re-aligned and it is proposed to prohibit vehicles accessing the southern sections of the old road from the B3344. The proposed order is to prohibit all vehicles along the sections that are no longer suitable for vehicles and will bring our orders in line with this on-street arrangement. This proposal will align the speed limits with the existing on-street lighting and signing.

Specifically, the restrictions proposed are for avoiding danger to persons or other traffic using the road or any other road or for preventing the likelihood of any such danger arising, for facilitating the passage on the road or any other road of any class of traffic (including pedestrians) and for preserving or improving the amenities of the area through which the road runs.
