

**Devon County Council (Queens Drive and Maer Road, Exmouth)
(No Waiting At Any Time and Pay & Display) Amendment Order**

Devon County Council propose to make this under the Road Traffic Regulation Act 1984 to introduce in Exmouth

NO WAITING AT ANY TIME on specified lengths of **Maer Road, Exmouth**

PAY & DISPLAY (Tariff Exmouth B) Max Stay 24 Hours No Motor Caravans At Any Time on specified lengths of **Queens Drive, Exmouth**

PAY & DISPLAY (Tariff Exmouth B) Max Stay 24 Hours No Motor Caravans 8pm-8am on specified lengths of **Maer Road and Queens Drive (Easter Spur), Exmouth**

Pay & Display Tariffs for Exmouth B are: All days 24 hours / day inc Bank Hols exc Christmas Day: 1 Apr-30 Sep 1 hour £1.30, 2 hours £2.50, 4 hours £5.00, 8 hours £7.30, 24 hours £12.00; 1 Oct-31 Mar 1 hour 90p, 2 hours £2.20, 4 hours £4.50, 8 hours £5.70, 24 hours £9.90.

There will be the usual exemptions including those in relation to the picking up and setting down of passengers, loading/unloading of goods and disabled persons vehicles.

Statement of Reasons

It is proposed to amend the motorcaravan prohibition on Queens Drive and merge it with the pay and display restriction to aid enforcement and simplify the signs. At the same time it is proposed to introduce pay and display on Maer Road with an overnight motorcaravan prohibition and No Waiting At Any Time across various accesses to allow and manage parking all year round.

Specifically, the order will preserve or improve the amenities of the area through which the road runs and for avoiding danger to persons or other traffic using the road or any other road or for preventing the likelihood of any such danger arising.
