## Whipton Lane, Sweetbrier Lane & Georges Close, Exeter – Proposed Waiting Restriction Amendments and Road Humps

Devon County Council propose to make Devon County Council (Whipton Lane, Exeter) (Waiting Restrictions) Amendment Order under the Road Traffic Regulation Act 1984 to introduce:

No Waiting At Any Time on a specified length of Whipton Lane Revocation of No Waiting At Any Time on specified lengths of Georges Close and Whipton Lane

Under sections 23 of Road Traffic Regulation Act 1984 and 90A of the Highways Act 1980 it is proposed to construct

FLAT TOP ROAD HUMP – 100mm high, 5.2 metres long and full width of the carriageway and to be constructed on **Sweetbrier Lane**, centred 15 metres south-east of the centre of roundabout of Sweetbrier Lane & Whipton Lane.

FLAT TOP ROAD HUMP – 100mm high, 5.2 metres long and full width of the carriageway and to be constructed on **Sweetbrier Lane**, centred 15 metres north-west of the centre of roundabout of Sweetbrier Lane & Whipton Lane.

FLAT TOP ROAD HUMP – 100mm high, 5.2 metres long and full width of the carriageway and to be constructed on **Whipton Lane**, centred 10.5 metres south-west of the junction with Georges Close.

## **Statement of Reasons**

Following a safety review of the roundabout at Sweetbrier Road and Whipton, it is proposed to introduce two road humps to improve safety for pedestrians crossing and calm traffic.

It is also proposed to make changes around the Georges Close and Whipton Lane junction to calm traffic and improve safety for cyclists. This includes the introduction of No Waiting At Any Time on the south-east side of Whipton Lane, the revocation of No Waiting At Any Time around the junction of Georges Close and Whipton Lane that will be replaced by a new build out and road hump across Whipton Lane.

The restrictions are proposed to avoid danger to persons or other traffic using the road or for preventing the likelihood of any such danger arising and for facilitating the passage on the road or any other road of any class of traffic (including pedestrians).
