

## **Proposed Prohibition of Motor Vehicles and Changes to Speed Limits, Northam**

Devon County Council propose to make these orders under the Road Traffic Regulation Act 1984 for Northam

**Devon County Council (Buckleigh Road (B3236) & Stanwell Hill, Northam) (30 & 40 mph Speed Limits) Order 5901** propose to extend the 30 mile per hour speed limit on Buckleigh Road (B3236), by virtue street lighting, by revoking the existing 40 from its current location to a point 29 metres south of Silford Cross; and to change the 30 mile per hour speed limit on Stanwell Hill from a restricted road (by virtue street lighting) to a 30 mile per hour speed limit by Order

**Devon County Council (Daddon Hill Road to Raleigh Hill Road, Northam) (Prohibition of Motor Vehicles) Order 5902** to introduce prohibition of motors on **Daddon Hill Road to Raleigh Hill Road** from its junction with "Road heading southeast from Silford Cross" to a point 189 metres north-east of that junction. The division will be by a new road through the new housing development and by Buckleigh Road

### **Statement of Reasons**

As part of a new housing development to the south of Buckleigh it is proposed to extend the current 30-mph limit on Buckleigh Road to a point just south of Silford Cross. It is also proposed to prohibit motor vehicles on a short section of **Daddon Hill Road to Raleigh Hill Road** to the north of Silford Cross as this length of road is being re-aligned/ replaced with a new road through the new housing development. In addition, it is proposed to make adjustments to update descriptions to ensure that measurements in the traffic order correspond with existing on street signing.

Specifically, the orders will avoid danger to persons or other traffic using the road or any other road or for preventing the likelihood of any such danger arising, for facilitating the passage on the road or any other road of any class of traffic (including pedestrians) and for preserving or improving the amenities of the area through which the road runs.
