

Devon County Council (Teignbridge HATOC) (Traffic Regulation) Amendment Order

Devon County Council propose to make this under the Road Traffic Regulation Act 1984 to introduce in

ASHBURTON: No Waiting At Any Time on specified lengths of Chuley Road, Eastern Road, Miner's Close and North Street; **Loading Only Mon-Sat 8am-6pm** on a specified length of North Street; **No Loading Mon-Fri 8am-9.30am and 3pm-4.30pm** on specified lengths of Woodland Road;

BISHOPSTEIGNTON: No Waiting At Any Time on a specified length of Murley Crescent;

BOVEY TRACEY: No Waiting At Any Time on specified lengths of Templar Place;

COCKWOOD: No Waiting At Any Time on specified lengths of Cofton Hill;

DAWLISH: No Waiting At Any Time on specified lengths of Church Street, East Cliff Road, Elm Grove Road, John Nash Drive, Richards Close, Shillingate Close and Summerhayes;

EXMINSTER: No Waiting At Any Time on a specified length of Days-Pottles Lane;

IDE: No Waiting At Any Time on specified lengths of Fore Street;

KENTON: No Waiting At Any Time on specified lengths of Slittercombe Lane;

KINGSKERSWELL: No Waiting At Any Time on specified lengths of Coffinswell Lane and Daccabridge Road;

KINGSTEIGNTON: No Waiting At Any Time on specified lengths of Chudleigh Road, Clifford Avenue, Coronation Road, Crossley Moor Road, Exeter Road, Hele Road, Longford Lane, Newcross Park, Rydon Road and Rydon Acres; **No Loading Mon-Fri 8am-9.30am and 3pm-4.30pm** on specified lengths of Chudleigh Road, Clifford Avenue and Newcross Park;

NEWTON ABBOT: No Waiting At Any Time on specified lengths of Ogwell Mill Road and Woodleigh Road; **No Loading Mon-Fri 8am-9.30am and 3pm-4.30pm** on specified lengths of Ogwell Mill Road and Woodleigh Road;

TEIGNMOUTH: No Waiting At Any Time on specified lengths of Barnpark Road, Elizabethan Way, Grove Crescent, Higher Brimley Road, Landscore Road and New Road.

Where appropriate there will be the usual exemptions including those in relation to picking up/setting down passengers, loading/unloading goods and disabled persons vehicles.
