

**Devon County Council (Marsh Road, Newton Abbot) (No Waiting At Any Time)
Amendment Order**

Devon County Council make the following order under 1, 2, 4, 45, 46, 49, 53 and part IV of schedule 9 of the Road Traffic Regulation Act 1984 and of all other enabling powers

- 1 This order comes into force _____ and may be cited as “Devon County Council (Marsh Road, Newton Abbot) (No Waiting At Any Time) Amendment Order”

- 2 The schedules in part 1 are added to Devon County Council (Traffic Regulation & On-Street Parking Places) Consolidation Order 2020 as amended and the lengths of road in part 2 are revoked from the corresponding schedules of that order

PART 1 RESTRICTIONS

Schedule 1.001 No Waiting At Any Time

Marsh Road, Newton Abbot

- (i) the north side from a point 21 metres east of the western extended property boundary of Lemon Court for a distance of 15 metres in an easterly direction
- (ii) the north side from a point 42 metres east of the western extended property boundary of Lemon Court to its closed eastern end including turning head
- (iii) the north side from its junction with Cricket Field Road to a point 6 metres east of the western extended property boundary of Lemon Court

Schedule 5.182 Pay & Display (Tariff Newton Abbot A) Mon-Sat 9am-5pm Max Stay 1 Hour

Marsh Road, Newton Abbot

- (i) the north side from a point 36 metres east of the western extended property boundary of Lemon Court for a distance of 6 metres in an easterly direction
- (ii) the north side from a point 6 metres east of the western extended property boundary of Lemon Court for a distance of 15 metres in an easterly direction

PART 2 REVOKED RESTRICTIONS

Schedule 1.001 No Waiting At Any Time

Marsh Road, Newton Abbot

- (i) the north side from a point 12 metres east of its junction with Cricket Field Road to its closed south-western end including turning head
- (ii) the north side from a point 45 metres east of its junction with Cricket Field Road for a distance of 5 metres in an easterly direction

- (iii) the north side from a point 56 metres east of its junction with Cricket Field Road to its closed eastern end including turning head

**Schedule 5.182 Pay & Display (Tariff Newton Abbot A) Mon-Sat 9am-5pm
Max Stay 1 Hour**

Marsh Road, Newton Abbot

- (i) the north side from a point 60 metres east of its junction with Cricket Field Road for a distance of 6 metres in an easterly direction
- (ii) the north side from a point 20 metres east of its junction with Cricket Field Road for a distance of 25 metres in an easterly direction
