

## Devon County Council (North Devon HATOC) (Traffic Regulation) Amendment Order

Devon County Council propose to make this under the Road Traffic Regulation Act 1984 to introduce in

**BARNSTAPLE: No Waiting At Any Time** on specified lengths of Ashleigh Crescent, Cyprus Terrace, Goodleigh Road, Upcott Avenue and Willow Tree Road; **No Waiting Mon-Sat 9am-5pm** on specified lengths of Newport Road; **Loading Only At Any Time** on a specified length of Queen Street; **Limited Waiting Mon-Sat 9am-5pm 3 Hours No Return Within 6 Hours** on specified lengths of Newport Road;

**BICKINGTON: No Waiting At Any Time** on specified lengths of Bickington Road;

**COMBE MARTIN: Keep Clear - No Stopping At Any Time** on a specified length of High Street;

**GEORGEHAM: No Waiting At Any Time** on a specified length of Glebe Field;

**ILFRACOMBE: No Waiting At Any Time** on specified lengths of Bicclescombe Park Road, Bradwell Road, Castle Hill, Fortescue Road, Highfield Road, Hillside Road, Langleigh Road, St Brannocks Park Road, Station Road, The Quay and Watermouth Road; **No Loading At Any Time** on a specified length of The Quay;

**LYNTON: No Waiting At Any Time** on specified lengths of Market Street;

**SOUTH MOLTON No Waiting Mon-Sat 8am-6pm** on a specified length of Elysian Court;

**STICKLEPATH: No Waiting At Any Time** on specified lengths of Beechwood Avenue, Bickington Road, Cleave Road and Westfield Avenue;

**SWIMBRIDGE: School Entrance Clearway - No Stopping At Any Time** on a specified length of Barnstaple Hill;

**WITHERIDGE: No Waiting At Any Time** on specified lengths of West Street.

Where appropriate there will be the usual exemptions including those in relation to picking up/setting down passengers, loading/unloading goods and disabled persons vehicles.

### Statement of Reasons

The restrictions are being proposed to resolve minor local issues that have been reported to the council and considered as part of the North Devon Highways and Traffic Orders Committee annual local waiting restrictions programme.
