Devon County Council propose to make this under the Road Traffic Regulation Act 1984 to introduce

Limited Waiting Mon-Sat 9am-6pm 2 Hours No Return Within 4 Hours on a specified length of Glasshouse Lane
Pay & Display (Tariff Exeter B1 8am-6pm Mon-Sat 15 mins 30p, 30 mins 80p, 1 hour £2.50, 2 hours £3.70; 11am-5pm Sun & Bank Hols exc Christmas Day 1 hour £1.50, 2 hours £3.70) Max Stay 2 Hours (Exemption for Residents Zone E Permit Holders) on a specified length of Barnfield Hill

Residents Parking At Any Time Zone L on a specified length of Barnardo Road

Residents Parking At Any Time Zone M on a specified length of Service Road for 1 to 57 Isca Road

Residents Parking At Any Time Zone F on specified lengths of Blackboy Road, Elmside and Iddesleigh Road

Residents Parking At Any Time Zone C on specified lengths of Clifton Road and Parr Street

Residents Parking At Any Time Zone K on specified lengths of Lower Coombe Street

Residents, charity business occupier permits £30 annually, visitor permits £30 per batch of 30, business permits annual cost: 1st permit £30, 2nd permit £75, 3rd permit £150; annual trade permit £45, short stay trade permits £60 per book of 20, daily trade permit £5, weekly trade permit £25; guest house/hotel visitors permit £30 per batch of 20 permits; essential visitor and care worker permits are free (PERMIT PRICES ARE CURRENTLY UNDER REVIEW SO THESE MAY VARY IF THE ORDER GOES AHEAD)

School Entrance Clearway - No Stopping At Any Time on a specified length of Union Street

Revocation of No Waiting At Any Time on specified lengths of Wrefords Lane

Revocation of No Stopping At Any Time Except Local Buses on a specified length of Russell Way

Topsham: **No Waiting At Any Time** on specified lengths of Follett Road, Newcourt Road and Pound Lane

Where appropriate there will be the usual exemptions including those in relation to picking up/setting down passengers, loading/unloading goods and disabled persons vehicles.

Statement of Reasons

The restrictions are proposed to avoiding danger to persons or other traffic using the road or for preventing the likelihood of any such danger arising, for facilitating the passage on the road or any other road of any class of traffic (including pedestrians) and to preserve/improving the amenities of the area through which the roads run.
