

## Devon County Council (Mid Devon HATOC) (Traffic Regulation) Amendment Order

Devon County Council propose to make this under the Road Traffic Regulation Act 1984 to introduce in

**BAMPTON: No Waiting At Any Time** on specified lengths of Castle Street and Road from Lower Lodfin Cross to Castle Street (B3190);

**BRADNINCH: No Waiting At Any Time** on specified lengths of Cullompton Hill, Hen Street, Kensham Avenue, Millway and West End Road;

**CHERITON BISHOP: No Waiting At Any Time** on a specified length of Road from Cottage Cross to Froggy Mill Cross;

**CREDITON: No Waiting At Any Time** on specified lengths of Albert Road, Commonmarsh Lane, Dokkum Road, George Hill, Peoples Park Road and Road from Fordton Cross to Station Cross; **No Waiting Mon-Sat 8am-6pm** on a specified length of Dokkum Road;

**CULLOMPTON: No Waiting At Any Time** on specified lengths of Crow Green, Pound Square and Saunders Way; **School Entrance Clearway - No Stopping At Any Time** on specified lengths of St Andrews Estate;

**NEWTON ST CYRES: No Waiting At Any Time** on a specified length of Godolphin Close;

**NOMANSLAND: No Waiting At Any Time** on a specified length of Road from Five Crosses to Nomansland Cross;

**SANDFORD: No Waiting At Any Time** on specified lengths of Back Lane, Road from West Lodge Cross to Rose and Crown Hill Cross and The Square;

**SILVERTON: No Waiting At Any Time** on a specified length of Silverdale;

**TIVERTON: No Waiting At Any Time** on specified lengths of Higher Wellbrook Street, Lowman Green and Orkney Mews.

Where appropriate there will be the usual exemptions including those in relation to picking up/setting down passengers, loading/unloading goods and disabled persons vehicles.

## Statement of Reasons

The restrictions are being proposed to resolve minor local issues that have been reported to the council and considered as part of the Mid Devon Highways and Traffic Orders Committee local waiting restrictions programme. Specific details of what is proposed at each location can be found within the deposit documents.

The restrictions are proposed to avoiding danger to persons or other traffic using the road or for preventing the likelihood of any such danger arising, for facilitating the passage on the road or any other road of any class of traffic (including pedestrians) and to preserve/improving the amenities of the area through which the roads run.
