

**Devon Country Council (Various Roads, Barnstaple)
(Derestriction, 30mph & 40mph Speed Limit) Order**

Devon County Council make this order in exercise of powers under sections 82, 83, 84, part IV of schedule 9 of the Road Traffic Regulation Act 1984 and of all other enabling powers

1. This order comes into force _____ and maybe cited as ‘Devon County Council (Various Roads, Barnstaple) (Derestriction, 30mph & 40mph Speed Limit) Order _____”
2. No person shall drive a motor vehicle at a speed exceeding 30 miles per hour on the length of road specified in schedule 1
3. No person shall drive a motor vehicle at a speed exceeding 40 miles per hour on the lengths of road specified in schedule 2
4. The lengths of road specified in schedule 3 cease to be restricted for the purpose of section 81 of the Act
5. No speed limit imposed by this order applies to vehicles falling within regulations 3(4) of the Road Traffic Exemptions (Special Forces) (Variation and Amendment) Regulations 2011
6. The orders in schedule 4 are revoked as specified

Schedule 1 30mph Speed Limit

Length of road in Barnstaple, North Devon

A39 (Shirwell Road), from a point 495 metres east of its junction with B3230 to a point 1005 metres east of its junction with B3230

Schedule 2 40mph Speed Limit

Lengths of road in Barnstaple, North Devon

A39 (North Road), from a point 26 metres south of the roundabout at access to North Devon Hospital to a point 138 metres north of its junction with Raleigh Road

A39 (North Road), from the access to Westaway and The Pound House to its junction with A39 (Shirwell Road)

A39 (Shirwell Road), from its junction with A39 (North Road) to a point 495 metres east of its junction with B3230

B3230, from its junction with A39 to a point 71 metres north-east of that junction

Schedule 3 Speed Derestriction

Length of road in Barnstaple, North Devon

Road past Roborough Farmhouse, from a point 92 metres north-east of its junction with Access Road to North Devon Hospital to a point 18 metres east of the boundary between Mayo Cottage and 1 Raleigh Park
