

Proposed Prohibition of Motor Vehicles, Filham

Devon County Council propose to make Devon County Council (Filham, Ugborough) (Prohibition of Motor Vehicles) Order 5828 under the Road Traffic Regulation Act 1984

to introduce PROHIBITION OF MOTOR VEHICLES on the:

- **C157 (Road from Cross in Hand to Peekmill Bridge Cross)** from its junction with “Davids Lane” in a north-westerly direction for a distance of 164 metres
- **C157 (Road from Cross in Hand to Peekmill Bridge Cross)** from its junction with “Road South from Filham Cross” in a south-easterly direction for direction for a distance of 179 metres
- **Z1921 (Track from North Filham towards A38)** from its junction with C157 (Road from Cross in Hand to Peekmill Bridge Cross) in a southerly direction for distance of 49 metres

The general diversion route will be via Davids Lane, B3213 and Road South from Filham Cross. The diversion route to Spring Cottage will be via B3213 and the new road through the new housing development and either by Davids Lane or Road South from Filham Cross.

Statement of Reasons

As part of phase 2 of the Bloor Homes housing development in Filham, south, of the B3213, to prohibit motor vehicles on a section of the Z1921 (Track from North Filham towards A38) and on two sections of the C157 (Road from Cross in Hand to Peekmill Bridge Cross).

Specifically, the orders will avoid danger to persons or other traffic using the road or any other road or for preventing the likelihood of any such danger arising, for facilitating the passage on the road or any other road of any class of traffic (including pedestrians) and for preserving or improving the amenities of the area through which the road runs.
