

Proposals for St Anns Chapel & Bigbury

Devon County Council propose to make these for St Anns Chapel and Bigbury under the Road Traffic Regulation Act 1984

Devon County Council (Bullhorn Cross to Chapel Cross, Bigbury) (Prohibition of Motor Vehicles) Order 5921 to introduce PROHIBITION OF MOTOR VEHICLES on the road from Bullhorn Cross to Chapel Cross Road (outside the Pickwick Inn) from its junction with the B3392 for a distance of 23 metres

Devon County Council (Various Roads, St Anns Chapel & Bigbury) (Restricted Road & 30mph Speed Limit) Order 6029 to introduce 30MPH SPEED LIMIT on the new Road behind Old Chapel and extending further west along the Bullhorn Cross to Chapel Cross Road. For ease of reference existing restrictions are in the draft order

Statement of Reasons

A new development is being built west of the B3392 which will see a new road being built (Road behind Old Chapel) that will provide an improved alternative route between the B3392 and Ringmore, it is proposed that the new road has a 30mph speed limit which would also include an extension on the Ringmore road (Bullhorn Cross to Chapel Cross). Once the new road is constructed it is proposed that the existing junction, adjacent to The Pickwick Inn, is closed by the introduction of a prohibition of motor vehicles to ensure that all traffic uses the junction to the south with improved visibility and safety.

The restrictions are proposed to avoid danger to persons or other traffic using the road or any other road or for preventing the likelihood of any such danger arising and for facilitating the passage on the road or any other road of any class of traffic (including pedestrians).
