

Devon County Council (Various Roads, Parishes of Abbotsham & Bideford) (30mph & 40mph Speed Limits & Restricted Road) Order

Devon County Council make the following order in exercise of powers under sections 82, 83, 84, part IV of schedule 9 of the Road Traffic Regulation Act 1984 and of all other enabling powers

1. This order comes into force _____ and may be cited as “*Devon County Council (Various Roads, Parishes of Abbotsham & Bideford) (30mph & 40mph Speed Limits & Restricted Road) Order*”
2. The length of road specified in schedule 1 is a restricted road for the purpose of section 81 of the Act
3. No person shall drive a motor vehicle at a speed exceeding 30mph on the lengths of road specified in schedule 2
4. No person shall drive a motor vehicle at a speed exceeding 40mph on the length of road specified in schedule 3
5. No speed limits imposed by this order applies to vehicles falling within regulation 3(4) of the Road Traffic Exemptions (Special Forces) (Variation and Amendment) Regulations 2011
- ~~6.~~ The orders in schedule 4 are revoked as specified

SCHEDULE 1 RESTRICTED ROAD

Lengths of roads in the Parishes of Abbotsham and Bideford in the District of Torridge:-

CLOVELLY ROAD (C776) - from a point 431 metres west of its junction with Scratchface Lane to a point 549 metres west of that junction.

SCHEDULE 2 30MPH Speed Limit

Lengths of roads in the Parishes of Abbotsham in the District of Torridge:-

ROAD FROM CLOVELLY ROAD TO LITTLEHAM CROSS (C490) from its junction with Clovelly Road (C776) to a point 186 metres south of that junction.

SCHEDULE 3 40MPH Speed Limit

Lengths of roads in the Parishes of Abbotsham and Bideford in the District of Torridge:-

CLOVELLY ROAD (C776) from a point 549 metres west of its junction with Scratchface Lane to its junction with A39 (Bideford By-Pass)

A39 (Bideford By-Pass) from a point 55 metres south-west of the middle of the Clovelly Road (C776) & A39 roundabout to a point 61 metres north-east of the centre of that roundabout.
