Devon County Council propose to make this under the Road Traffic Regulation Act 1984 for

**BARNSTAPLE:** To introduce **Disabled Badge Holders Only At Any Time** on specified lengths of Charles Dart Crescent & Litchdon Street; **Limited Waiting 8am-6pm 1 Hour No Return Within 1 Hour (Exemption for Residents Permit Holders)** on a specified length of Fair View

**BUDLEIGH SALTERTON:** To introduce **Disabled Badge Holders Only At Any Time** on a specified length of Boyne Road

**EXETER:** To introduce **Disabled Badge Holders Only At Any Time** on specified lengths of Cambridge Street, Cecil Road, Chestnut Avenue, Ladysmith Road, Salters Road & Welcome Street; **Limited Waiting Mon-Sat 9am-6pm 2 Hours No Return Within 4 Hours** on a specified length of Cecil Road; **Limited Waiting Mon-Fri 9am-6pm 2 Hours No Return Within 4 Hours** on a specified length of Church Terrace; **Residents Parking At Any Time Zone B** on specified lengths of Albion Street & Clinton Street; **Residents Parking At Any Time Zone E** on a specified length of Archibald Road; **Residents Parking At Any Time Zone F** on a specified length of Lucas Avenue; **Residents Parking At Any Time Zone G** on a specified length of Prospect Park; **Residents Parking At Any Time Zone M** on a specified length of Welcome Street; Revocation of **Disabled Badge Holders Only At Any Time** on specified lengths of Beacon Avenue, Chestnut Avenue, Hawthorn Road, Magnolia Avenue & Stuart Road

**EXMOUTH:** To introduce **Disabled Badge Holders Only At Any Time** on a specified length of Nasmith Close

**KINGSTEIGNTON:** Revocation of **Disabled Badge Holders Only At Any Time** on a specified length of Sandpath Road

**MODBURY:** To introduce **Disabled Badge Holders Only At Any Time** on a specified length of Galpin Street; Revocation of **Disabled Badge Holders Only At Any Time** on a specified length of Galpin Street

**NEWTON ABBOT:** To introduce **Disabled Badge Holders Only At Any Time** on a specified length of Waltham Road

Where appropriate there will be the usual exemptions including those in relation to picking up/setting down passengers, loading/unloading goods & disabled persons vehicles

Residents, charity business occupier, supported living, school business, motorcycle, scooter & other vehicles band A permits (less than 100g/km) £35 annually, other vehicles bands B–K (101-225g/km) 1<sup>st</sup> permit £35, 2<sup>nd</sup> permit £55, 3<sup>rd</sup> permit £65; bands L-M (226+ g/km) 1<sup>st</sup> permit £35, 2<sup>nd</sup> permit £65, extra permits £65; virtual visitor permits £30 per issue (200 hours for schemes not operating at all times/350 hours for schemes operating at all times - allocated in 1 hour sessions), physical 24 hour visitor permits £30 per issue of 30 permits, business permits annual cost: 1<sup>st</sup> permit £35, 2<sup>nd</sup> permit £75, 3<sup>rd</sup> permit £150; annual trade permit £45, short stay trade permits £60 per book of 20, daily trade permit £5, weekly trade permit £25; guest house/hotel visitors permit £30 per batch of 20 permits; essential visitor permits £10 annually, care worker permits are free
