**(Waiting Restrictions & Parking Places) Amendment Order**

Devon County Council (DCC) propose to make this under the Road Traffic Regulation Act 1984 for

ASHBURTON: Introduction of **No Waiting At Any Time** in specified lengths of Balland Lane

AXMINSTER: Introduction of **No Waiting 9am-6pm** in a specified length of West Street

BARNSTAPLE: Introduction of **No Waiting At Any Time** in specified lengths of Belmont (Vicarage Lawn), Fort Street, Fort Terrace and Under Minnow Road; Introduction of **No Waiting Mon-Fri 8am-6pm** in a specified length of Highbury Road; Introduction of **Pay & Display (Tariff Barnstaple A 1 hour £1.80, 2 hours £3.10) Mon-Sat inc bank hols 8am-6pm Max Stay 2 Hours** in specified lengths of Boutport Street, Seventh Street and Vicarage Street; Introduction of **Residents Parking At Any Time Zone E** in specified lengths of Fort Street and Hills View; Introduction of **Residents Parking At Any Time Zone B** in specified lengths of Fort Terrace and Salem Street; Introduction of **Residents Parking (Zonal) At Any Time Zone E** in a specified length of Fort Street; Revocation of **No Waiting 8am-6pm** in specified lengths of Boutport Street. Residents, charity business occupier, supported living, school business, motorcycle, scooter and other vehicles band A permits (less than 100g/km) £35 annually, other vehicles bands B–K (101-225g/km) 1<sup>st</sup> permit £35, 2<sup>nd</sup> permit £55, 3<sup>rd</sup> permit £65; bands L-M (226+ g/km) 1<sup>st</sup> permit £35, 2<sup>nd</sup> permit £65, extra permits £65; virtual visitor permits £30 per issue (200 hours for schemes not operating at all times/350 hours for schemes operating at all times - allocated in 1 hour sessions), physical 24 hour visitor permits £30 per issue of 30 permits, business permits annual cost: 1<sup>st</sup> permit £35, 2<sup>nd</sup> permit £75, 3<sup>rd</sup> permit £150; annual trade permit £45, short stay trade permits £60 per book of 20, daily trade permit £5, weekly trade permit £25; essential visitor permits £10 annually, care worker permits are free

BUDLEIGH SALTERTON: Introduction of **No Waiting At Any Time** in specified lengths of Access To Public Hall, High Street, Station Road and West Hill; Introduction of **Limited Waiting 9am-6pm 1 Hour No Return Within 2 Hours** in a specified length of Station Road; Revocation of **No Waiting At Any Time** in a specified length of Cliff Road Access to Redcliff Court

CHALLABOROUGH: Introduction of **No Waiting At Any Time** in specified lengths of Road From Bigbury Bay Holiday Park To Marwynne and Road From Bowling Green Cross To Challaborough Sea Front

CHILLINGTON: Introduction of **No Waiting At Any Time** in specified lengths of A379 Coleridge Lane To Carehouse Cross; Introduction of **Limited Waiting Mon-Sat 8am-6pm 30 Mins No Return Within 1 Hour** in specified lengths of A379 Coleridge Lane To Carehouse Cross

CHUDLEIGH: Introduction of **No Waiting At Any Time** in a specified length of Oldway Spur Road

CHUDLEIGH KNIGHTON: Introduction of **School Entrance Clearway - No Stopping At Any Time** in specified lengths of B3344 and Road From Claycutters Arms To Arnwood

CREDITON: Introduction of **No Waiting At Any Time** in a specified length of Market Street; Introduction of **Disabled Badge Holders Only At Any Time** in a specified length of Market Street

DAWLISH: Introduction of **No Waiting At Any Time** in specified lengths of Alexandra Road, Brookdale Terrace, Brunswick Place, Jubilee Bridge, Marine Parade, Piermont Place, Shaftesbury Close, Teignmouth Hill, West Cliff Road and West Cliff; Introduction of **Pay & Display (Tariff Dawlish B Mon-Sat inc bank hols 30 mins 60p, 1 hour £1.50, 2 hours £2.60; Sun 1 hour £1, 2 hours £2.80) 9am-6pm** in specified lengths of Brunswick Place and Marine Parade; Introduction of **Disabled Badge Holders Only Mon-Sat 9am-6pm Max Stay 2 Hours** in a specified length of Brunswick Place; Introduction of **Loading For Goods Vehicles Only Mon-Sat 8am-6pm Max Stay 30 Mins No Return Within 1 Hour** in a specified length of Brunswick Place

IVYBRIDGE: Introduction of **No Waiting At Any Time** in specified lengths of Blachford Road

STICKLEPATH: Introduction of **No Waiting At Any Time** in a specified length of Sticklepath Terrace; Introduction of **Residents Parking At Any Time Zone H** in a specified length of Sticklepath Terrace

STOKE GABRIEL: Introduction of **No Waiting At Any Time** in a specified length of School Hill; Introduction of **Limited Waiting 9am-midnight 1 Jun-30 Sep 3 Hours No Return Within 1 Hour** in a specified length of School Hill; Introduction of **School Entrance Clearway - No Stopping At Any Time** in a specified length of School Hill

Where appropriate there will be the usual exemptions including those in relation to picking up/setting down passengers, loading/unloading goods and disabled persons vehicles.

### **Statement of Reasons**

Over time discrepancies have come to light between what is marked on the ground and what is detailed within the traffic regulation order. This order aims to resolve these discrepancies. Specific details of what is proposed at each location can be found attached to the relevant plan within the deposit documents.

The restrictions are proposed to avoiding danger to persons or other traffic using the road or for preventing the likelihood of any such danger arising, for facilitating the passage on the road or any other road of any class of traffic (including pedestrians) and to preserve/improving the amenities of the area through which the roads run.
