

Devon County Council (North Devon HATOC) (Traffic Regulation) Amendment Order

Devon County Council propose to make this under the Road Traffic Regulation Act 1984 to introduce in

BARNSTAPLE: No Waiting At Any Time on specified lengths of Abbey Road, Chaddiford Lane, Paternoster Row, Sowden Lane, Vicarage Lawn and Victoria Lawn; **No Loading At Any Time** on a specified length of Paternoster Row; **Loading Only At Any Time Exemption for Queens Theatre Permit Holders** on a specified length of Boutport Street

BICKINGTON: No Waiting At Any Time on a specified length of Bickington Road

BRAUNTON: No Waiting At Any Time on specified lengths of Higher Park Road and Seven Acre Lane

CROYDE: No Waiting At Any Time on a specified length of Tom's Field

GEORGEHAM: No Waiting At Any Time on specified lengths of Longland lane and Rock Hill

ILFRACOMBE: No Waiting At Any Time on specified lengths of Church Road, Fore Street, The Quay and St Brannocks Road; **No Loading At Any Time** on a specified length of The Quay; **No Waiting 10am-6pm between 15 Mar and 31 Oct** on a specified length of St Brannocks Road; **No Loading Mon-Fri 8.30am-9.15am and 3pm-3.30pm** on a specified length of Princess Avenue; **Disabled Badge Holders Only At Any Time** on a specified length of Princess Avenue; **Loading Only At Any Time** on a specified length of High Street

INSTOW: No Waiting At Any Time on specified lengths of New Road

STICKLEPATH: Revocation of No Waiting Mon-Fri 9am-5pm on specified lengths of Old Torrington Road

WRAFTON: No Waiting At Any Time on specified lengths of Wrafton Road

Where appropriate there will be the usual exemptions including those in relation to picking up/setting down passengers, loading/unloading goods and disabled persons vehicles.

Statement of Reasons

The restrictions are being proposed to resolve minor local issues that have been reported to the council and considered as part of the North Devon Highways and Traffic Orders Committee annual local waiting restrictions programme. The restrictions are proposed to avoiding danger to persons or other traffic using the road or for preventing the likelihood of any such danger arising, for facilitating the passage on the road or any other road of any class of traffic (including pedestrians) and to preserve/improving the amenities of the area through which the roads run.
