

## **Devon County Council (Various Roads, Dartmouth) (Speed Limits) Order**

Devon County Council make this order under sections 82, 83, 84 and part IV of schedule 9 of the Road Traffic Regulation Act 1984 (“Act”) & of all other enabling powers

1. This order comes into force \_\_\_\_\_ and may be cited as “Devon County Council (Various Roads, Dartmouth) (Speed Limits) Order \_\_\_\_\_”
2. The lengths of road specified in schedule 1 are restricted roads for the purpose of section 81 of the Act
3. No person shall drive any motor vehicle at a speed exceeding 30mph on the lengths of road specified in schedule 2
4. No person shall drive any motor vehicle at a speed exceeding 20mph on the lengths of road specified in schedule 3
5. No speed limit imposed by this order applies to vehicles falling within regulation 3(4) of the Road Traffic Exemptions (Special Forces) (Variation and Amendment) Regulations 2011
6. The County of Devon (Various Roads, Dartmouth) (20 & 30mph Speed Limits) Order 2007 is revoked in its entirety

### **Schedule 1      Restricted Road**

*Length of road in Dartmouth in the district of South Hams*

**A3122 Norton Cross to Townstal Road** from a point 63 metres west of the roundabout at Nelson Road to a point 104 metres west of that roundabout

### **Schedule 2      30mph Speed Limit**

*Lengths of road in Dartmouth in the district of South Hams*

**Weeke Hill** from a point 37 metres north-east of the property boundary of Devoden/Highclere Weeke Hill to a point 47 metres south-west of that property boundary

**Nelson Road** from its junction with the access to the South West Water sewage treatment works to its junction with the access to Speedwell Units

**A379** from its junction with Milton Lane to a point 161 metres south of its junction with Milton Lane

### **Schedule 3      20mph Speed Limit**

*Lengths of road in Dartmouth in the district of South Hams*
