

## **Devon County Council Fair Oak Close, Clyst Honiton – Bus Gate and No Waiting At Any Time Order**

Devon County Council propose to make these orders under the Road Traffic Regulation Act 1984 for Fair Oak Close, Clyst Honiton

### **Devon County Council (Fair Oak Close, Clyst Honiton) (No Waiting At Any Time) Order**

The Introduction of **No Waiting At Any Time** on specified lengths of **Fair Oak Close** and **Fair Oak Close (Spur Past Silverdown Office Park)**, Clyst Honiton. There will be the usual exemptions including those in relation to picking up/setting down passengers, loading/unloading goods and disabled persons vehicles.

### **Devon County Council (Fair Oak Close, Clyst Honiton) (Bus Gate) Order**

The Introduction of **Prohibition of Vehicles on Fair Oak Close (Spur Past Silverdown Office Park)** from a point 178 metres south-east of its junction with Fair Oak Close (main thoroughfare) to a point 258 metres south- east of that junction.

### **Statement of Reasons**

This link road was constructed to maintain access to various properties whilst Long Lane was closed for improvement works. When these works are complete it is proposed to introduce a Bus Gate to restrict traffic to only cycles and buses to create a quiet and safer route for walking and cycling and to encourage the use of sustainable modes of transport. To ensure buses can use this road it is proposed to introduce No Waiting At Any Time.

The restrictions are proposed to avoid danger to persons or other traffic using the road or for preventing the likelihood of any such danger arising, for facilitating the passage on the road or any other road of any class of traffic (including pedestrians) and to preserve/improving the amenities of the area through which the roads run.
