

Devon County Council (Mid Devon HATOC) (Traffic Regulation) Amendment Order

Devon County Council make the following order under sections 1, 2, 4, 32, 35, part IV of schedule 9 of the Road Traffic Regulation Act 1984 and of all other enabling powers

- 1** This order comes into force _____ and may be cited as “Devon County Council (Mid Devon HATOC) (Traffic Regulation) Amendment Order _____”
- 2** The schedules in part 1 are added to Devon County Council (Traffic Regulation & On-Street Parking Places) Consolidation Order 2020 as amended and the lengths of road in part 2 are revoked from the corresponding schedules of the specified orders

PART 1 RESTRICTIONS

BOLHAM

Schedule 11.023 Buses Only At Any Time

Road from Bolham Primary School to Knightshayes Cross, Bolham

the south-east side from a point 8 metres north-east of its junction with Road from Bolham Primary School to Petroc Mid Devon Campus for a distance of 23 metres in an north-easterly direction

CREDITON

Schedule 1.001 No Waiting At Any Time

Church Street, Crediton

the east side from a point 45 metres north of its junction with Union Road for a distance of 12 metres in a northerly direction

Churchill Drive, Crediton

- (i) the east side from its junction with Alexandra Road for a distance of 14 metres in a southerly direction
- (ii) the west side from its junction with Alexandra Road for a distance of 61 metres in a southerly direction

St Martin's Lane, Crediton

the east side from its junction with Alexandra Road for a distance of 58 metres in a southerly direction

Schedule 9.001 School Entrance Clearway - No Stopping At Any Time

St Martins Lane, Crediton

- (i) the west side from a point 105 metres south of its junction with Alexandra Road for a distance of 25.56 metres in a southerly direction
- (ii) the west side from a point 28 metres south of its junction with Alexandra Road for a distance of 31.56 metres in a southerly direction
