

Devon County Council (West Devon HATOC) (Traffic Regulation) Amendment Order

Devon County Council make the following order under sections 1, 2, 4, 32, 35, part IV of schedule 9 of the Road Traffic Regulation Act 1984 and of all other enabling powers

- 1** This order comes into force _____ and may be cited as “Devon County Council (West Devon HATOC) (Traffic Regulation) Amendment Order _____”
- 2** The schedules in part 1 are added to Devon County Council (Traffic Regulation & On-Street Parking Places) Consolidation Order 2020 as amended and the lengths of road in part 2 are revoked from the corresponding schedules of that order

PART 1 RESTRICTIONS

BERE ALSTON

Schedule No 4.234 - Limited Waiting Mon-Sat 12pm-4pm 30 Minutes No Return Within 30 Minutes

Fore Street, Bere Alston

the north-east side from a point 14 metres south-east of its junction with Bedford Street for a distance of 17 metres in a south-easterly direction

BRIDESTOWE

Schedule No 9.001 - School Entrance Clearway - No Stopping At Any Time

Road From The Square To Pigs Leg Cross, Bridestowe

the south-west side from a point 15 metres south-east of the eastern building line of Courtyard House for a distance of 25.56 metres in a south-easterly direction

Fore Street, Bridestowe
