

## **Devon County Council (Lynmouth, Tors Road) (Residents Parking Zone A) Amendment Order**

Devon County Council make the following order under sections 1, 2, 4, 32, 35, 45, 46, 49, 53, part IV of schedule 9 of the Road Traffic Regulation Act 1984 and of all other enabling powers

- 1 This order comes into force \_\_\_\_\_ and may be cited as “Devon County Council (Lynmouth, Tors Road) (Residents Parking Zone A) Amendment Order \_\_\_\_\_”
- 2 The schedules in part 1 are added to Devon County Council (Traffic Regulation & On-Street Parking Places) Consolidation Order 2020 as amended and the lengths of road in part 2 are revoked from the corresponding schedules of the specified orders

### **SCHEDULES IN PART 1**

- 1.001 No Waiting At Any Time
- 6.015 Residents Parking At Any Time Zone A
- 7.001 Disabled Badge Holders Only At Any Time
- 15.002 Pay by Phone (Tariff Lynmouth A) 10am-6pm Max Stay 4 Hours (Exemption for Residents Zone A Permit Holders)

### **PART 1 RESTRICTIONS**

#### **Schedule 1.001 No Waiting At Any Time**

##### **Tors Road, Lynmouth**

- (i) the north-east side from a point 186 metres south-east of the boundary of Nos. 7/8 in a south-easterly direction to a point 190 metres from that boundary
- (ii) the north-east side from a point 207 metres south-east of the boundary of Nos. 7/8 in a south-easterly direction to a point 209 metres from that boundary
- (iii) the north-east side from a point 217 metres south-east of the boundary of Nos. 7/8 in a south-easterly direction to a point 219 metres from that boundary
- (iv) the north-east side from a point 245 metres south-east of the boundary of Nos. 7/8 Tors Road in a south-easterly direction to the end of the road
- (v) the north-east side from its junction with Countisbury Hill to a point 6 metres north-west of the property boundary of Nos. 7/8
- (vi) the north-east side from a point 115 metres south-east of the boundary of Nos. 7/8 in a south-easterly direction to a point 125 metres from that boundary
- (vii) the south-west side from a point 16 metres south-east of its intersection with the extended eastern building line of number 27 Tors Road in an easterly direction for a distance of 16 metres
- (viii) the south-west side from a point 44 metres south-east of its intersection with the extended eastern building line of number 27 Tors Road in an easterly direction for a distance of 3.5 metres
- (ix) the south-west side from its junction with Lyndale in an easterly direction for a distance of 240 metres

#### **Schedule 6.015 Residents Parking At Any Time Zone A**

##### **Tors Road, Lynmouth**

- (i) the north-east side from a point 60.6 metres south-east of the boundary of

- (ii) Nos. 7/8 in a south-easterly direction to a point 115 metres from the boundary the north-east side from a point 6 metres north-west of the boundary of Nos. 7/8 in a south-easterly direction for a distance of 9 metres
- (iii) the north-east side from a point 190 metres south-east of the boundary of Nos. 7/8 in a south-easterly direction to a point 207 metres from that boundary
- (iv) the north-east side from a point 9.6 metres south-east of the boundary of Nos. 7/8 in a south-easterly direction to a point 54 metres from that boundary.

**Schedule 7.001 Disabled Badge Holders Only At Any Time**

**Tors Road, Lynmouth**

- (i) the north-east side from a point 54 metres south-east of the boundary of Nos. 7/8 in a south-easterly direction for a distance of 6.6 metres

**Schedule 15.002 Pay by Phone (Tariff Lynmouth A) 10am-6pm Max Stay 4 Hours (Exemption for Residents Zone A Permit Holders)**

**Tors Road, Lynmouth**

- (i) the north-east side from a point 209 metres south-east of the boundary of Nos. 7/8 in a south-easterly direction to a point 217 metres from that boundary
- (ii) the north-east side from a point 219 metres south-east of the boundary of Nos. 7/8 in a south-easterly direction to a point 245 metres from that boundary
- (iii) the north-east side from a point 125 metres south-east the boundary of Nos. 7/8 in a south-easterly direction to a point 186 metres from that boundary
- (iv) the south-west side from a point 47.5 metres south-east of its intersection with the extended eastern building line of number 27 Tors Road in an easterly direction for a distance of 5 metres (the end of the road)
- (v) the south-west side from a point 32 metres south-east of its intersection with the extended eastern building line of number 27 Tors Road in an easterly direction for a distance of 12 metres
