Devon County Council propose to make this under the Road Traffic Regulation Act 1984 for

Barnstaple Introduction of **Disabled Badge Holders Only At Any Time** on a specified length of Charles Dart Crescent

Bideford Introduction of **Disabled Badge Holders Only At Any Time** on a specified length of Meddon Street; Introduction of **Limited Waiting Mon-Sat 8am-6pm 1 Hour No Return Within 1 Hour (Exemption for Residents Zone C Permit Holders)** on a specified length of Victoria Grove

Bishopsteignton Extension of **Disabled Badge Holders Only At Any Time** on a specified length of Fore Street

Crediton Revocation of **Disabled Badge Holders Only At Any Time** on a specified length of Buller Road

Dartmouth Extension of **Disabled Badge Holders Only At Any Time** on a specified length of Mayors Avenue

Exeter Introduction of **Disabled Badge Holders Only At Any Time** on specified lengths of Briar Crescent, Chestnut Avenue, Rifford Road and Williams Avenue; Revocation of **Disabled Badge Holders Only At Any Time** on specified lengths of Beacon Lane, Ladysmith Road, Priory Road and St Annes Road

Harbertonford Extension of **Disabled Badge Holders Only At Any Time** on a specified length of Bow Road

Liverton Introduction of **Disabled Badge Holders Only At Any Time** on a specified length of Road From Cummings Cross To Liverton Court

Newton Abbot Introduction of **Limited Waiting Mon-Sat 8am-6pm 1 Hour No Return Within 1 Hour (Exemption for Residents Zone A Permit Holders)** on a specified length of Tudor Road; Introduction/moving of **Residents Parking At Any Time Zone A** on a specified length of Waltham Road. Residents, charity business occupier, supported living, school business, motorcycle, scooter and other vehicles band A permits (below 101g/km) £35 annually, other vehicles bands B–K (101-225g/km) 1<sup>st</sup> permit £35, 2<sup>nd</sup> permit £55, 3<sup>rd</sup> permit £65; bands L-M (over 225g/km) 1<sup>st</sup> permit £35, 2<sup>nd</sup> permit £65, extra permits £65; virtual visitor permits £30 per issue (200 hours for schemes not operating at all times/350 hours for schemes operating at all times - allocated in 1 hour sessions), physical 24 hour visitor permits £30 per issue of 30 permits, essential visitor permits £10 annually, business permits annual cost: 1<sup>st</sup> permit £35, 2<sup>nd</sup> permit £75, 3<sup>rd</sup> permit £150; annual trade permit £45, short stay trade permits £60 per book of 20, daily trade permit £5, weekly trade permit £25; care worker permits are free; Introduction/moving of **Disabled Badge Holders Only At Any Time** on a specified length of Waltham Road

Topsham Extension of **Disabled Badge Holders Only At Any Time** on a specified length of Nelson Close

Where appropriate there will be the usual exemptions including those in relation to picking up/setting down passengers, loading/unloading goods and disabled persons vehicles.
