

**Devon County Council (Various Roads, Lapford & Pennymoor)
(Restricted Road & 30mph Speed Limit) Order**

Devon County Council make the following order in exercise of powers under sections 82, 83, 84 of the Road Traffic Regulation Act 1984 ("Act") and of all other enabling powers

- 1 This order comes into force _____ and may be cited as "Devon County Council Various Roads, Lapford & Pennymoor) (Restricted Road & 30mph Speed Limit) Order _____"
- 2 The lengths of road specified in schedule 1 are restricted roads for the purpose of section 81 of the Act
- 3 No person shall drive any motor vehicle at a speed exceeding 30mph on the lengths of road specified in schedule 2
- 4 No speed limit imposed by this order applies to vehicles falling within regulation 3(4) of the Road Traffic Exemptions (Special Forces) (Variation and Amendment) Regulations 2011

Schedule 1 Restricted Road

Length of road at Lapford in the District of Mid Devon

Rensey Lane for the entire length of the public highway

Lengths of road at Pennymoor in the District of Mid Devon

"Road from Pennymoor Cross to West Ruckham Cross" from its junction with **"Road from Pennymoor to Two Post Cross"** to a point 68 metres north-east of the boundary of No.3 & No.4 Moor View

"Road from Pennymoor to Two Post Cross" from its junction with **"Road from Pennymoor Cross to West Ruckham Cross"** to a point 20 metres north-west of the south-eastern building line of Higher Furze

Schedule 2 30mph Speed Limit

Lengths of road at Lapford in the District of Mid Devon

C480 (Road from Orchard Cross to Higher Forches Cross) from a point 57 metres south of the northern building line of 5 Higher Town Court to a point 55 metres north of that building line

Lengths of road at Pennymoor in the District of Mid Devon

"Road from Pennymoor Cross to West Ruckham Cross" from a point 68 metres north-east of the boundary of No.3 & No.4 Moor View to point 91 metres north-east of that building line

“Road from Pennymoor past Higher Yeadbury” from its junction with **“Road from Pennymoor Cross to West Ruckham Cross”** to a point 58 metres south-east of the boundary between Hawthorns and The Haven

“Road from Greenland Head Cross to Pennymoor Cross” for its entire length

“Road from Greenland Head Cross to Daniels Grave” from its junction with Road from Greenland Head Cross to Pennymoor Cross to a point 35 metres south of that junction
