## Langaton Lane, Exeter - No Waiting & Speed Limit Proposals

Devon County Council propose to make these under the Road Traffic Regulation Act 1984 to introduce in Broadclyst

Devon County Council (Langaton Lane, Exeter) (No Waiting At Any Time) Amendment Order to introduce **No Waiting At Any Time** on Langaton Lane both sides from the northern side of the railway bridge north-westerly for 37 metres, including the eastern spur. There will be the usual exemptions including those in relation to picking up/setting down passengers, loading/unloading goods and disabled persons vehicles.

Devon County Council (Langaton Lane, Exeter) (20mph Zone and Restricted Road) Order to introduce **20mph Zone** on Langaton Lane from 118 metres south-east of Pinn Valley Road to 159 metres south-east of that junction and **Restricted Road** (30mph by virtue of streetlighting) on Langaton Lane from 159 metres south-east of Pinn Valley Road to its junction with Tithebarn Way.

## **Statement of Reasons**

It is proposed to introduce No Waiting At Any Time to prevent parking in the turning head so that vehicles unaware of the prohibition restriction or delivering to properties are able to manoeuvre easily to make a return journey.

It is also proposed to extend the current 20mph zone and introduce a new 30mph speed limit to tie in with the additional street lighting due to be erected as part of the Langaton Lane Green Lane Scheme, Exeter and to reduce speed on the green lane allowing safer passage for all users.

Specifically, the restrictions are proposed to avoid danger to persons or other traffic using the road or any other road or for preventing the likelihood of any such danger arising, will facilitate the passage on the road of any class of traffic (including pedestrians) and will preserve or improve the amenities of the area which the road runs through.
