

Devon County Council (Ferndale Road Area, Exeter)
(Residents Parking Zone T5 & Waiting Restrictions) Amendment Order

Devon County Council propose to make this under the Road Traffic Regulation Act 1984 to introduce in Exeter:

No Waiting At Any Time on specified lengths of Barton Road, Beauford Road, Church Path Road, Churchill Road, Coleridge Road, Cordery Road, Cowick Lane, Edwin Road, Ferndale Road, Franklyn Drive, Holland Road, Larch Road, Old Vicarage Road, Pines Gardens, Pines Road, Powderham Road, Princes Street East, Princes Street North, Princess Street South, Queens Road, Regent Street, Rices Mews and Sydney Road; **Limited Waiting Mon-Sat 8am-6pm 2 Hours No Return Within 4 Hours** on specified lengths of Ferndale Road and Pines Road; **Limited Waiting Mon-Sat 9am-6pm 30 Minutes No Return Within 1 Hour** on a specified length of Cowick Street; **Limited Waiting Mon-Sat 8am-6pm 2 Hours No Return Within 4 Hours (Exemption for Residents Zone T5 Permit Holders)** on specified lengths of Barton Road, Church Path Road, Churchill Road, Coleridge Road, Cowick Lane, Duckworth Road, Edwin Road, Holland Road, Larch Road, Old Vicarage Road, Parkhouse Road, Powderham Road, Princes Street East, Queens Road, Regent Street, Rices Mews, Shaftesbury Road and Sydney Road; **Limited Waiting Mon-Sat 8am-6pm 3 Hours No Return Within 6 Hours** on specified lengths of Princes Street North, School Road and Sydney Road; **Pay & Display (Tariff Exeter T 8am-8pm Mon-Fri Maximum Stay 2 Hours 30 Minutes Free, 1 Hour £1.50, 2 Hours £2.80, Sat & Sun Free) (Exemption for Residents Zone T5 Permit Holders)** on specified lengths of Old Vicarage Road and Queens Road; **Residents Parking (Zonal) 8am-8pm Zone T5** on specified lengths of Barton Road, Chieftain Way, Church Path Road, Churchill Road, Coleridge Road, Cordery Road, Duckworth Road, Edwin Road, Ferndale Gardens, Ferndale Road, Holland Road, Larch Road, Parkhouse Road, Pines Gardens, Pines Road, Powderham Road, Princes Square, Princes Street East, Princes Street North, Princes Street South, Princes Street West, Queens Road, Regent Street, Rices Mews, Sandford Place, School Road and Shaftesbury Road; **Residents Parking 8am-8pm Zone T5** on specified lengths of Beauford Road, Cowick Lane, Ferndale Road, Old Vicarage Road, Pines Road, Princes Street East, Queens Road and Sydney Road; **Disabled Badge Holders Only At Any Time** on specified lengths of Barton Road, Church Path Road, Churchill Road, Coleridge Road, Cowick Lane, Duckworth Road, Ferndale Road, Parkhouse Road, Powderham Road, Princes Street North, Regent Street and Shaftesbury Road; Revocation of **Residents Parking At Any Time Zone B** on a specified length of School Road. Where appropriate there will be the usual exemptions including those in relation to picking up/setting down passengers, loading/unloading goods and disabled persons vehicles.

Residents, charity business occupier, supported living, school business, motorcycle, scooter and other vehicles band A permits (up to 100g/km) £35 annually, other vehicles bands B–K (101-225g/km) 1st permit £35, 2nd permit £55, 3rd permit £65; bands L-M (over 225g/km) 1st permit £35, 2nd permit £65, extra permits £65; virtual visitor permits £30 per issue (200 hours for schemes not operating at all times/350 hours for schemes operating at all times - allocated in 1 hour sessions), physical 24 hour visitor permits £30 per issue of 30 permits, business permits annual cost: 1st permit £35, 2nd permit £75, 3rd permit £150; annual trade permit £45, short stay trade permits £60 per book of 20, daily trade permit £5, weekly trade permit £25; guest house/hotel visitors permit £30 per batch of 20 permits; essential visitor permits £10 annually, care worker permits are free.

STATEMENT OF REASONS

The proposals aim to introduce residents parking schemes that have been agreed for advertising to improve access and to improve parking options for local residents.

The restrictions are proposed to avoid danger to persons or other traffic using the road or for preventing the likelihood of any such danger arising, for facilitating the passage on the road or any other road of any class of traffic (including pedestrians) and to preserve/improving the amenities of the area through which the roads run.
