## Devon County Council (Various Roads, Dog Village) (No Waiting At Any Time) Amendment Order

Devon County Council propose to make this under the Road Traffic Regulation Act 1984 to introduce:

No Waiting At Any Time, Old Coach Road, Dog Village (i) the north-east side from its junction with Road From Tower View To Dog Village Cross in a westerly direction to a point 37 metres south-east of the south-eastern property boundary of 3 Dog Village Bungalows (ii) the south-west side from its junction with Road From Tower View To Dog Village Cross in a north-westerly direction for a distance of 13 metres, Road From Tower View To Dog Village Cross, Dog Village (i) the north-west side from a point 73 metres south-west of its junction with Old Coach Road in a north-easterly direction to a point 2 metres north-east of the south-western property boundary of number 12 Woodbury View (ii) the south-east side from the northern property boundary of No. 1 Tower View to a point 24 metres south-west of that point.

Where appropriate there will be the usual exemptions including those in relation to picking up/setting down passengers, loading/unloading goods and disabled persons vehicles.

## **Statement of Reasons**

As part of the new Road From Tower View To Dog Village Cross Footways scheme (near Clyst Vale Community) it has been agreed to deliver improvements to pedestrian/cycle facilities on the route, to improve safety for children travelling to school, as well as other pedestrians/cyclists using the road. It is proposed to introduce and extend No Waiting At Any Time restrictions to prevent obstructive parking at the new crossing point at the junction of Old Coach Road/Road from Tower View to Dog Village Cross where the width of the carriageway is narrowed down. This will improve visibility and road safety for all road users, especially for pedestrians using the crossing point.

Specifically, the restrictions are proposed to avoid danger to persons or other traffic using the road or any other road or for preventing the likelihood of any such danger arising and will preserve or improve the amenities of the area which the road runs through.
