

## **Devon County Council (Chudleigh Road, Exeter) (Waiting Restrictions) Amendment Order**

Devon County Council make the following order under sections 1, 2, 4, 32, 35, part IV of schedule 9 of the Road Traffic Regulation Act 1984 and of all other enabling powers

- 1** This order comes into force \_\_\_\_\_ and may be cited as “Devon County Council (Chudleigh Road, Exeter) (Waiting Restrictions) Amendment Order”
- 2** The schedules in part 1 are added to Devon County Council (Traffic Regulation & On-Street Parking Places) Consolidation Order 2020 as amended and the lengths of road in part 2 are revoked from the corresponding schedules of that order.

### **PART 1            RESTRICTIONS**

#### **Schedule No**

#### **1.001   No Waiting At Any Time**

##### **Chudleigh Road, Exeter**

- (i) the east side from its junction with Dawlish Road spur southwards for a distance of 84 metres
- (ii) the east side from a point 10 metres north of the extended northern kerbline of the access to Lucerne House car park southwards to its junction with Chantry Meadow
- (iii) the north-west side from a point 94 metres south-west of its junction with Cludens Close for a distance of 26 metres in a south-westerly direction
- (iv) the west side from its junction with Ide Lane in a southerly direction for a distance of 60 metres
- (v) the west side from a point 88 metres south of its junction with Ide Lane in a southerly direction to a point 18 metres south of its junction with Cludens Close

#### **7.001   Disabled Badge Holders Only At Any Time**

##### **Chudleigh Road, Exeter**

- (i) the west side from a point 60 metres south of its junction with Ide Lane for a distance of 6.6 metres in a southerly direction

- (iii) the north-west side from its junction with Ide Lane for a distance of 187 metres in a southerly direction
- (iv) the west side from its junction with Cludens Close southwards for a distance of 18 metres in a southerly direction

- (i) the east side from a point 80 meters south of the Pedestrian Crossing opposite Ide Lane for a distance of 7 metres in a southerly direction
