Devon County Council (Various Roads, Uffculme) (20mph Speed Limit & Restricted Roads) Order

Devon County Council make the following order in exercise of powers under sections 82, 83, 84, part IV of schedule 9 of the Road Traffic Regulation Act 1984 ('the Act') and of all other enabling powers

- 1. This order comes into force on and may be cited as "Devon County Council (Various Roads, Uffculme) (20mph Speed Limit & Restricted Roads) Order"
- 2. No person shall drive a motor vehicle at a speed exceeding 20 miles per hour on the roads specified within schedule 1
- 3. The lengths of road specified in schedule 2 are restricted roads for the purpose of section 81 of the Act
- 4. The Devon County Council (Restricted Roads) (No 15) (East) Order 1976 is revoked in its entirety
- No speed limit imposed by this order applies to vehicles falling within regulation 3(4) of the Road Traffic Exemptions (Special Forces) (Variation and Amendment) Regulations 2011

SCHEDULE 1: 20MPH SPEED LIMIT
