## **STATEMENT OF REASONS**

It is proposed to introduce 20mph speed restriction on several roads in Ottery St Mary with the intention that it will lead to a reduced likelihood of collisions and an improvement of local amenities. It is also proposed to extend the existing 30mph limit by virtue of restricted road status beyond the car park to Otter Garden Centre to improve the safety for vehicles accessing this car park and pedestrians who walk along this length of road.

Specifically, the restrictions are proposed to avoid danger to persons or other traffic using the road or any other road or for preventing the likelihood of any such danger arising, will facilitate the passage on the road of any class of traffic (including pedestrians) and will preserve or improve the amenities of the area which the road runs through.
