Devon County Council (A386 & Various Roads, Mary Tavy) (Speed Limits) Order

Devon County Council make the following order in exercise of powers under section 82, 83, 84, part IV of the Road Traffic Regulation Act 1984 and of all other enabling powers

- 1. This order comes into force and maybe cited as "Devon County Council (A386 & Various Roads, Mary Tavy) (Speed Limits) Order *
- 2. The lengths of road specified in schedule 1 are restricted roads for the purpose of section 81 of the Act
- 3. No person shall drive any motor vehicle at a speed exceeding 30mph on the lengths of road specified in schedule 2
- 4. No person shall drive any motor vehicle at a speed exceeding 40mph on the lengths of road specified in schedule 3
- 5. No speed limit imposed by this order applies to vehicles falling within regulation 3(4) of the Road Traffic Exemptions (Special Forces) (Variation and Amendment) Regulations 2011
- 6. The orders listed in schedule 4 are revoked in their entirety

Schedule 1 Restricted Roads

Lengths of road in Mary Tavy, West Devon

A386, from a point 46 metres south of its junction with Station Road to a point 80 metres north of the northern building line of the property formerly known as Royal Standard

Bal Lane, for its entire length

Brentor Road, from its junction with A386 to its junction with Warne Lane

Chapel Lane, for its entire length

Crossings Close, for its entire length

Great Fellingfield, for its entire length

Moor View, for its entire length

The Oaks, for its entire length

South View, for its entire length

Warne Lane, from its junction with Brentor Road to a point 31 metres north of its junction with Great Fellingfield

Warren Road, for its entire length

Wheal Road, for its entire length

Schedule 2 30mph Speed Limit

Lengths of road in Mary Tavy, West Devon

Brentor Road, from its junction with Warne Lane to a point 227 metres north of its junction with Brentor Road spur (road leading to Moorland Hall)

Road from Bal Lane to Dowerland Farm, for its entire length

Road from Dowerland Farm to Dingles Farm, from its junction with Road from Bal Lane to Dowerland Farm to a point 48 metres north-east of that junction

Road from Dowerland Farm to Kent House, for its entire length

Road from Kent House to The Power Station, for its entire length

Road past the Old Rectory, for its entire length

Station Road, from its junction with A386 to a point 25 metres south-west of its junction with Warne Lane

Warne Lane, from a point 31 metres north of its junction with Great Fellingfield to its junction with Station Road

Schedule 3 40mph Speed Limit

Lengths of road in Mary Tavy, West Devon

A386, from a point 80 metres north of the northern building line of the property formerly known as Royal Standard to a point 10 metres north of the entrance to property known as Edgemoor House

A386, from a point 46 metres south of its junction with Station Road to a point 640 metres south of that junction
