

**Devon County Council (Barnstaple Railway Station, Barnstaple) (Waiting Restrictions)
Amendment Order**

Devon County Council make the following order under sections 1, 2, 4, 32, 35, part IV of schedule 9 of the Road Traffic Regulation Act 1984 and of all other enabling powers

- 1 This order comes into force and may be cited as “Devon County Council (Barnstaple Railway Station, Barnstaple) (Waiting Restrictions) Amendment Order ”
- 2 The schedules in part 1 are added to Devon County Council (Traffic Regulation & On-Street Parking Places) Consolidation Order 2024 as amended and the lengths of road in part 2 are revoked from the corresponding schedules of that order

PART 1 RESTRICTIONS

BARNSTAPLE

Schedule 1.001 No Waiting At Any Time

Access To Barnstaple Station Car Park, Barnstaple

- (i) the north-east side from its junction with Station Road to a point 46 metres north-west of the south-eastern building line of B&Q
- (ii) the south side from its junction with Station Road to its junction with Station Road (Bus Link)

Station Road, Barnstaple

- (i) both sides from its junction with the A3125 in a southerly direction to the end of the public highway

Station Road (Bus Link), Barnstaple

- (i) the south-west side from its junction with Station Road for a distance of 26 metres in a north-westerly direction
- (ii) the north-east side from its junction with Station Road to its junction with Access To Barnstaple Station Car Park
- (iii) the south-west side from a point 41 metres north-west of its junction with Station Road for a distance of 12 metres in a north-westerly direction

Schedule 3.001 No Loading At Any Time

Access To Barnstaple Station Car Park, Barnstaple

- (i) the north-east side from its junction with Station Road to a point 46 metres north-west of the south-eastern building line of B&Q

Schedule 11.023 Buses Only At Any Time

Station Road (Bus Link), Barnstaple

- (i) the south-west side from a point 26 metres north-west of its junction with Station Road for a distance of 15 metres in a north-westerly direction

STICKLEPATH

Schedule 1.001 No Waiting At Any Time

Sticklepath Terrace, Sticklepath

- (i) the north-west side from a point 105 metres south-west of its junction with Signal Terrace in a south westerly direction to a point 13 metres north of its junction with Busway From Barnstaple Station to Sticklepath Hill including the turning area
- (ii) the south-east side from its junction with Station Road in a south westerly direction to a point 13 metres north of its junction with Busway From Barnstaple Station to Sticklepath Hill

PART 2 REVOKED RESTRICTIONS

Schedule 1.001 No Waiting At Any Time

Station Road, Barnstaple

- (i) both sides from its junction with the A3125 to its closed Southern end
- (ii) the inner side from the Southern end of the island for the entire perimeter

Sticklepath Terrace, Sticklepath

- (i) the north-west side from a point 105 metres south-west of its junction with Signal Terrace to its south-western closed end
- (ii) the south-east side from its junction with Station Road for its entire length in a south-westerly direction including the turning point

Schedule 3.001 No Loading At Any Time

Seven Brethren Bank - Tesco Link Road, Barnstaple

- (i) both sides from its junction with Station Road to its junction with Seven Brethren Bank

Station Road, Barnstaple

- (i) both sides from its junction with the A3125 to its closed Southern end
- (ii) the inner side from the Southern end of the island for the entire perimeter
