SCHOOL ENTRANCE CLEARWAY – NO STOPPING AT ANY TIME on specified lengths of Garrison Road and March Close

**Devon County Council (March Close, Matford, Parish of Exminster) (20mph Speed Limit) Order 6200** to introduce

20MPH SPEED LIMIT on March Close for its entire length

## **Statement of Reasons**

As part of the development for the South West Exeter Housing Infrastructure Fund scheme, it is proposed to introduce No Waiting At Any Time and School Keep Clear restrictions on various roads leading to the new school. The proposals are intended to keep areas clear of any parked vehicles for children using various crossing points to access the school from the northern part of the estate.

In addition, it is proposed introduce a 20mph speed limit on March Close, the road where the new school is currently under construction. The design speed for the spine road through the development has been designed as 20mph, which was consented as part of discharge of condition for outline approval and it is understood that this should make the speed limit self-enforcing. All future new roads within the development will also require a 20mph speed limit TRO to ensure consistency and these will be progressed as and when needed.

The proposals will improve road safety for all road users including pedestrians and cyclists. Specifically, the restrictions are proposed to preserve or improve the amenities of the area through which the road runs.
