BUDLEIGH SALTERTON: **No Waiting At Any Time** on specified lengths of Dalditch Lane, Upper Stoneborough and Westfield Close;

COLYFORD: No Waiting At Any Time on a specified length of Seaton Road;

COLYTON: **No Waiting At Any Time** on a specified length of South Street; **Keep Clear – No Stopping At Any Time** on specified lengths of Grovers Meadow and South Street;

EXMOUTH: **No Waiting At Any Time** on specified lengths of Bapton Close, Bapton Lane, Douglas Avenue, Regents Gate, Shapter Court, Springfield Road and West Down Lane; **No Loading At Any Time** on a specified length of Maer Road; **School Entrance Clearway - No Stopping At Any Time** on specified lengths of Beacon Place, Gipsy Lane, Green Close, Moorfield Road and Regents Gate;

SEATON: Pay & Display (Tarriff Seaton B) 8am-8pm 1 Apr to 31 Oct Max Stay 4 Hours: 30 minutes £0.40; 1 hour £1.50; 2 hours £4.00; 3 hours £6.00; 4 hours £8.00 on a specified length of Esplanade; School Entrance Clearway - No Stopping At Any Time on specified lengths of Scalwell Lane and Valley View; Keep Clear - No Stopping At Any Time on a specified length of Valley View;

SIDBURY: No Waiting At Any Time on a specified length of Church Street;

SIDFORD: No Waiting At Any Time on specified lengths of Byes Lane and Higher Brook Meadow;

SIDMOUTH: **No Waiting At Any Time** on specified lengths of Deans Mead, Lawn Vista, Radway and Station Road; **No Loading At Any Time** on specified lengths of Station Road;

WOODBURY: **No Waiting At Any Time** on specified lengths of Broadway, Flower Street, Globe Hill, Greenway and Road From Gilbrook Cottages To Higher Venmoor Farm; **Limited Waiting Mon-Sat 9am-5pm 1 Hour No Return Within 2 Hours** on specified lengths of The Arch;

WOODBURY SALTERTON: School Entrance Clearway - No Stopping At Any Time on a specified length of Stony Lane.
