## Devon County Council (North Devon HATOC) (Traffic Regulation) Amendment Order

Devon County Council propose to make this under the Road Traffic Regulation Act 1984 to introduce in:

BARNSTAPLE: **No Waiting At Any Time** on specified lengths of Abbey Road, Access To 1 To 43 Heppenstall Road, Bear Street, Gorwell Road, Littabourne, Northfield Lane, Raleigh Meadow, St Georges Road, Tuly Street and Victoria Road; **No Loading At Any Time** on specified lengths of Bear Street, Bull Court and Tuly Street; **School Clearway** on specified lengths of Abbey Road;

BRAUNTON: No Waiting At Any Time on specified lengths of Church Street and Severn Acre Lane;

CROYDE: **No Waiting At Any Time** on specified lengths of Cott Lane and Pathfields; FREMINGTON: **No Waiting At Any Time** on specified lengths of Old School Lane; STICKLEPATH: **No Waiting At Any Time** on a specified length of Bickington Road; WOOLACOMBE: **No Waiting At Any Time** on specified lengths of Arlington Place.

Where appropriate there will be the usual exemptions including those in relation to picking up/setting down passengers, loading/unloading goods and disabled persons vehicles.
